Commencing at the centerline intersection of State Route 13 with Dover Township Road No. 607, said point being in the most Southerly corner of a 4.0 (+/-) acre parcel owned by the Golden Wings CB Radio Club of S.E. Ohio as recorded in Deed Book 346, Page 379 in the Athens County Recorder's Office, Athens County, Ohio; thence N 42°34'32" E along the centerline of said Dover Township Road No. 607 and the Southwesterly line of said 4.0 (+/-) acre parcel, 452.14 feet to a P.K. nail set; thence N 46°59'37"E continuing along the previously described line, 227.79 feet to a P.K. nail set; thence N 41°55'12"E continuing along said line, 32.50 feet to a point in the most Easterly corner of said 4.0 (+/-) acre parcel, said point also being in the most Southerly corner of a 3.45 (+/-) acre parcel owned by the Grantor herein (Northalleena M. Hall) as recorded in Deed Book 336 on Page 149 in said Recorder's Office, said point also being the real point of beginning of the parcel herein described.

Commencing at the centerline intersection of State Route 13 with Dover Township Road No. 607, said point being in the most Southerly corner of a 4.0 (+/-) acre parcel owned by the Golden Wings CB Radio Club of S.E. Ohio as recorded in Deed Book 346, Page 379 in the Athens County Recorder's Office, Athens County, Ohio; thence N 42°04'32" E along the centerline of said Dover Township Road No. 607 and the Southeasterly line of said 4.0 (+/-) acre parcel, 452.14 feet to a P.K. nail set; thence N 46°59'37" E continuing along the previously described line, 227.79 feet to a P.K. nail set; thence N 41°55'12" E continuing along said line, 32.50 feet to a point in the most Easterly corner of said 4.0 (+/-) acre parcel, said point also being in the most Southerly corner of a 3.45 (+/-) acre parcel owned by the Grantor herein (Northalleens M. Hall) as recorded in Deed Book 336 on Page 149 in said Recorder's Office; thence continuing N 41°55'12" E along said Southeasterly line of said 3.45 (+/-) acre parcel, 85.36 feet to a railroad spike set; thence N 48°58'08" W along a random line, 156.73 feet to a 1" iron bar set, passing through a 3/8" iron pin set at 15.00 feet, said 1" iron bar set also being the real point of beginning of the parcel herein described:


