## EXHIBIT "A"

Being a part of the tract of land that is now or formerly in the name of Gilbert G. Phillips as recorded in Official Record 82 at page 777, Athens County Recorder's Office, said tract being part of Fractional Lot 1 (Section 21), T10N, R14W, Dover Township, Athens County, State of Ohio and being more particularly described as follows:

Beginning, for reference, at the southwest corner of Fractional Lot 1 (Section 21);

Thence along the west line of Fractional Lot 1, North 04 degrees 55 minutes 16 seconds East a distance of 1096.98 feet to a point in the center of Township Road No. 293 and on a corner to the grantor, said point being the principal place of beginning for the tract herein described;

Thence leaving the center of said road and continuing along the west line of Fractional Lot 1 (Section 21) and along the grantor's west line, North 04 degrees 55 minutes 16 seconds East, passing through a 5/8" X 30" iron pin with a plastic identification cap set at 50.00 feet, going a total distance of 205.57 feet to a 5/8" X 30" iron pin with a plastic identification cap set;

Thence leaving the grantor's west line and the west line of Fractional Lot 1 (Section 21) and with a new line through the grantor's land the following two courses:

South 57 degrees 00 minutes 43 seconds East a distance of 393.09 feet to a 5/8" X 30" iron pin with a plastic identification cap set, and;
South 16 degrees 40 minutes 04 seconds West, passing through a 5/8" X 30" iron pin with a plastic identification cap set at 275.40 feet, going a total distance of 325.40 feet to a point in the center of [2] Township Road No. 293 and the grantor's southwest line;

Thence along the center of said road and the grantor's southwest lines the following three courses:

North 30 degrees 53 minutes 43 seconds West a distance of 94.62 feet to a point;


North 40 degrees 35 minutes 34 seconds West a distance of 183.15 feet to a point, and;
