Description of a 7.435 Acres - Tract "A"

Commencing at the North-west corner of Fraction #3,

Thence, South 87 degrees 36 minutes 36 seconds East, 68.64 feet to an iron pin set at the North-west corner of David Wakefield (480-655 O.R.) and being the point of beginning for the tract of land herein described:

Thence, along the East -line of Linscott (253-1849 O.R.):

S 03° 07' 20" W, 510.44 feet to an iron pin set;

Thence, along new-lines created by this survey:

N 84° 24' 08" E, 76.71 feet to an iron pin set;

N 65° 23' 08" E, 84.92 feet to an iron pin set ;

N 68° 14' 08" E, 204.82 feet to an iron pin set ;

S 85° 17' 20" E, 120.11 feet to an iron pin set ;

N 79° 09' 26" E, 66.27 feet to an iron pin set ;

N 65° 05' 36" E, 231.64 feet to an iron pin set;

1N 60° 55' 55" E, 100.10 feet to an iron pin set ;

N 47° 28' 11" E, 118.44 feet to an iron pin set ;

N 31° 25' 22" E, 42.36 feet to an iron pin set ;

N 9° 39' 55" E, 52.67 feet to an iron pin set ;

N 86° 44' 36" E, 47.00 feet to a point in Sand Ridge Road, passing an iron pin set at 26.21 feet ;

Thence, along Sand Ridge Road:

N 11° 43' 17" W, 32.02 feet to a railroad spike set;

Thence, along the lines of Karnes (312-735 O.R.) and Linscott (222-162 O.R.)

N 87° 36' 36" W, 957.81 feet to the point of beginning and containing 7.435 acres.



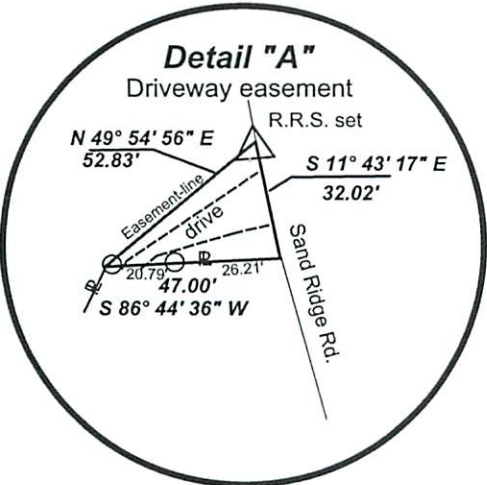
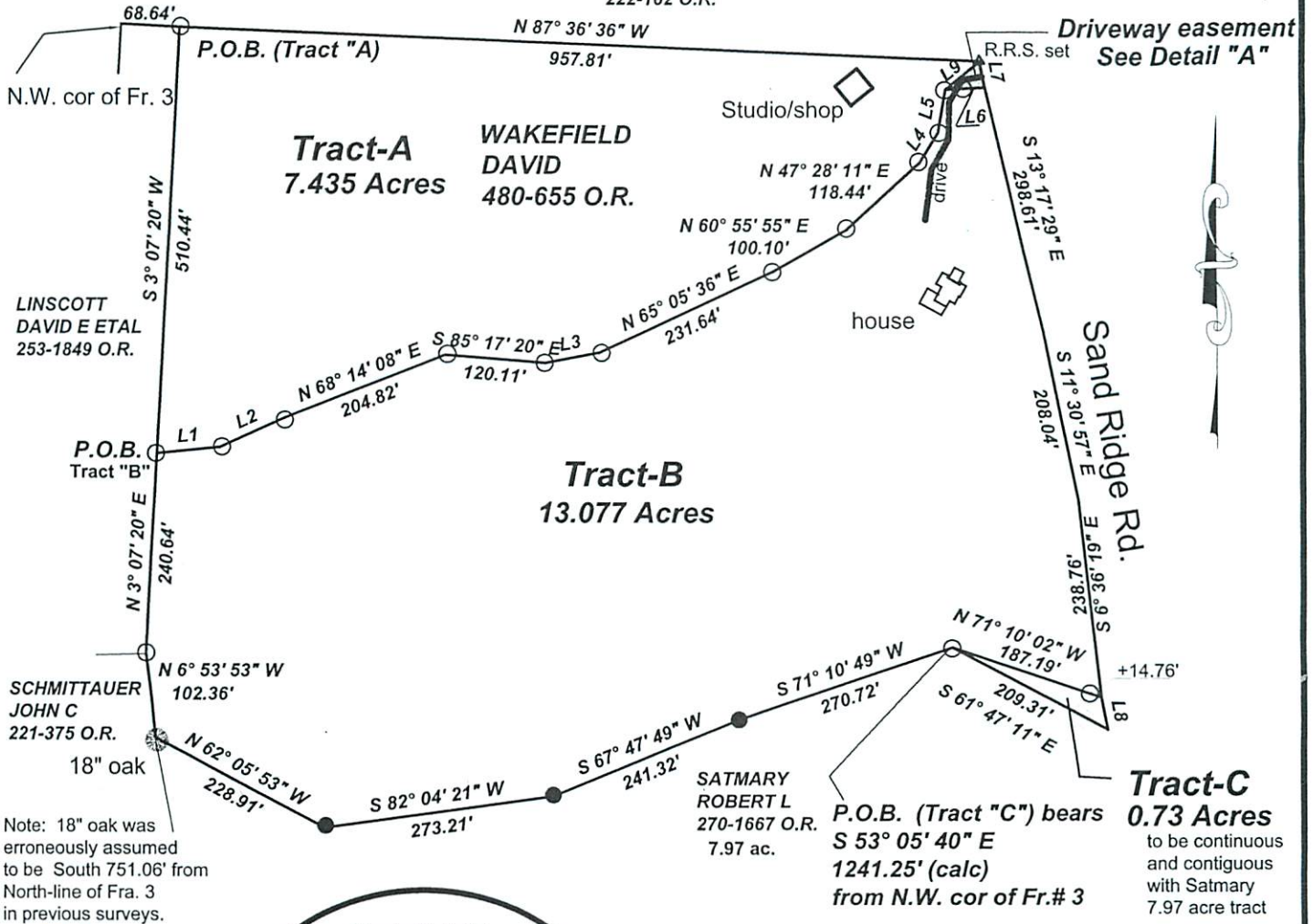

DESCRIPTION OF A DRIVEWAY EASEMENT

Situated in Fraction 3, Section 9, T.10, R.14, Dover Township, Athens County, Ohio and being more particularly described as follows:

Commencing at the North-west corner of Fraction #3,
Thence, South 87 degrees 36 minutes 36 seconds East, 1026.45 feet to a railroad spike set at the North-west corner of David Wakefield (480-655 O.R.) and being the point of beginning for the driveway easement herein described:

Thence, along Sand Ridge Road South 11 degrees 43 minutes 17 seconds East, 32.02 feet to a point;
Thence, leaving said road and along a new property line between a 7.435 acre tract and a 13.077 acre tract:

South 86 degrees 44 minutes 36 seconds West, 47.00 feet to an iron pin set, passing an iron pin set an 26.21 feet;

Thence, North 49 degrees 54 minutes 56 seconds East, 52.83 feet to the point of beginning
