

DESCRIPTION OF A 7.120 ACRE TRACT

Situated in Fraction 1, Section 14, T.10, R.14, Dover Township, Athens County, Ohio and being a part of Parcel G010010037101 as described in Volume 380, Page 323 of the Official Records of Athens County, Ohio and being more particularly described as follows:

Beginning at an iron pin found bearing S 61° 01' 13" E, 2972.14 feet (calculated) from the Northwest corner of Section 14:

Thence along new lines created by this survey the following five courses:

- (1) S 86° 42' 47" E, 355.78 feet to an iron pin set;
- (2) S 70° 59' 48" E, 296.06 feet to an iron pin set;
- (3) S 41° 13' 24" E, 373.12 feet to an iron pin set;
- (4) S 26° 54' 26" W, 157.19 feet to an iron pin set;
- (5) S 30° 52' 24" E, 36.90 feet to a point in Township Road 324 (Sand Ridge Road), passing an iron pin set at 17.41 feet;

Thence along said road the following four courses:

- (1) S 78° 32' 32" W, 36.50 feet to a point;
- (2) N 89° 28' 10" W, 139.03 feet to a point;
- (3) N 79° 19' 16" W, 229.24 feet to a point;
- (4) N 86° 25' 45" W, 202.44 feet to a point;

Thence leaving said road and along the East lines of Robinson (478-705 O.R.):

N 15° 40' 56" W, 445.50 feet to an iron pin found, passing an iron pin found at 23.92 feet;
N 49° 21' 02" W, 140.08 feet to the Point of Beginning and **containing 7.120 acres.**

Subject to all easements and rights of way of record.

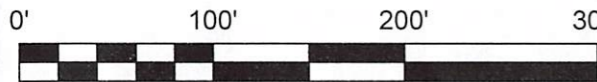
