2) Thence **S** 03 °28'27" **W** along the East property line of *Mary H. Hughes, the Grantor herein, (OR.165/Pg.846)*, the West property line of a tract now, or formerly, owned by Steven M. Lowery (OR.299/Pg.94), the East line of Section 24 and the West line of Section 18, **418.32 feet** to an iron pin w/cap set in the Southeast property corner of said *Mary H. Hughes, the Grantor herein, (OR.165/Pg.846)* and the Northeast property corner of a tract owned by the United States of America (DB.238/Pg.36), passing through 5' long x 3/4" I.D. Sched.40 White PVC Posts set at 100.2', 170.6', 241.5' and 313.1';

3) Thence N 88°24'55" W along the South property line of said Mary H. Hughes, the Grantor herein, (OR.165/Pg.846) and one of the Easterly property corners of said Jacob A. Stollard (OR.479/Pg.1490), said point in the existing railroad tie fence corner post being witnessed by an iron pin found that bears: N 10°04'28" W, 0.48 feet FROM said point, passing across the herein stated Dover-Trimble Township line, into Trimble Township, at a calculated distance of 432.22 feet, and, passing through 5' long x 3/4" I.D.
