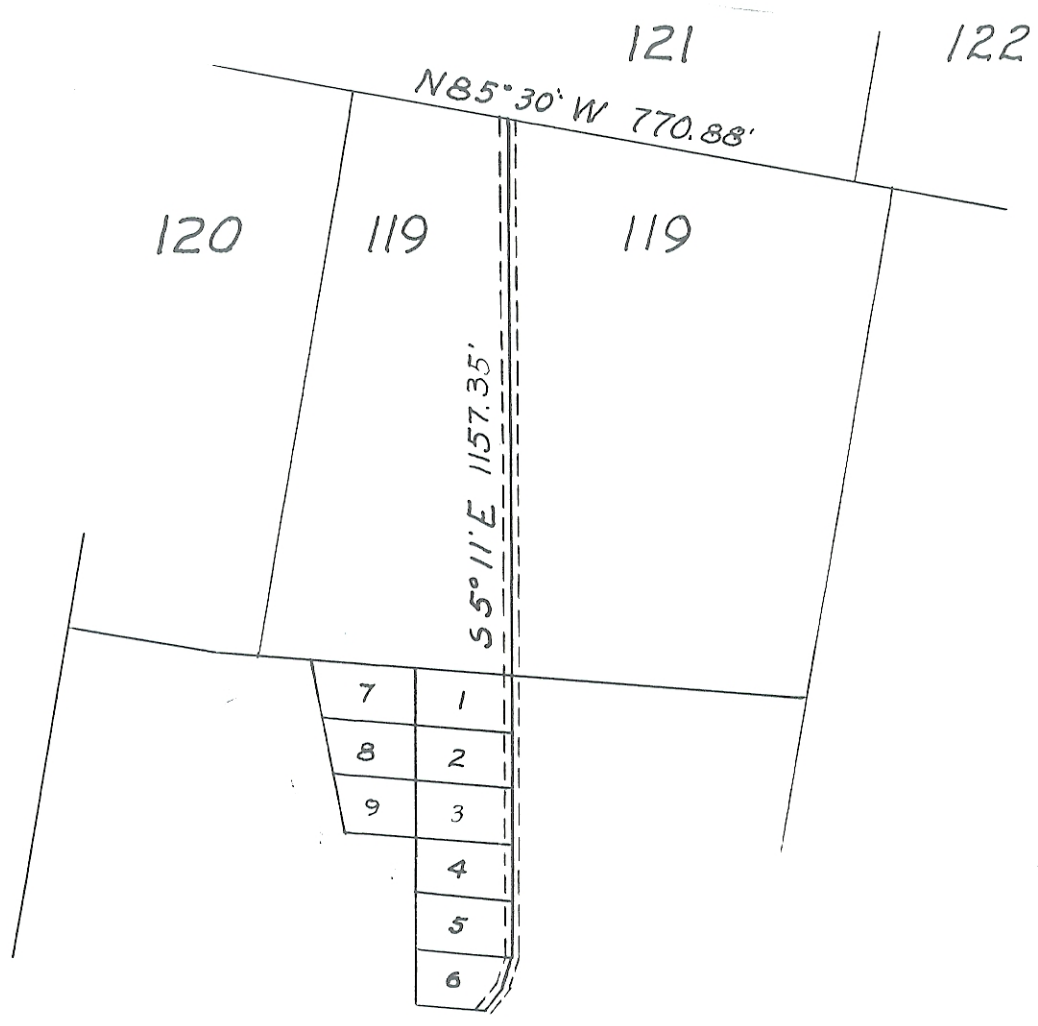


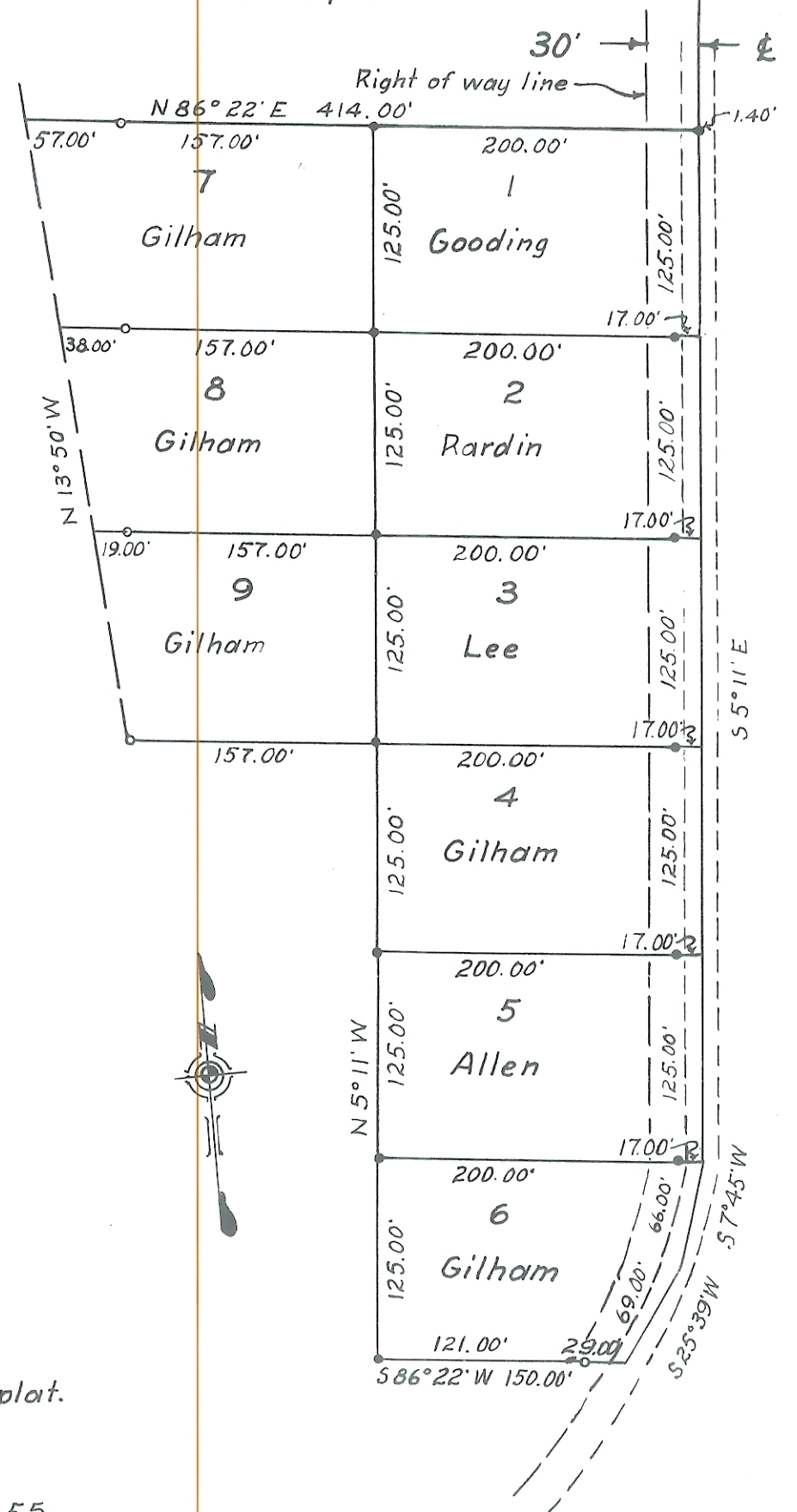
ENVELOPE: 326A
