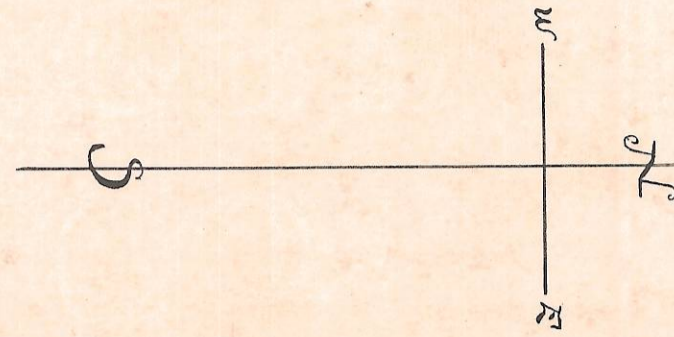


Fairfield Addition to Stewart Ohio

The accompanying plat is described as follows: Beginning at an iron pin in section line 160 ft. north of the southeast corner of fraction 30 range 12 town 6 section 21 in Rome township, thence west with the line of H. Biggins 52 poles 10 ft. to a stake, thence north 20 poles 2 feet, to a stake, thence east 4 poles 10 ft. to a stake thence north 29 poles 14 1/2 ft. to a stake, thence 48 poles to a stake in aforesaid section line thence south 50 poles to the place of beginning.
