

copy of proceedings relating to the annexation of certain territory to the village of Glouster.

To the Commissioners of Athens County, State of Ohio.  
The village of Glouster respectively represents that by an ordinance duly passed by its council on the 16<sup>th</sup> day of January 1906, the following described territory, situated in section 16, Trimble township, Athens County Ohio, and being all that part of the following described land lying south of a certain drain ditch running in a southeasterly direction through said tract of land, and being about two acres more or less also beginning at the southwest corner of fraction no. 4, being also on the east line of section 16, thence north 5 degrees east 198 feet to the middle of the public road, thence along the middle of said road 25 degrees west 427 feet to a corner; thence south 77 degrees west 164 feet to the east line of the right of way of the Buckingham Branch Railroad so called, thence south 122 degrees 15 seconds east along said east line of said railroad right of way 1278 feet to the intersection of said right of way line with the east line of said section 16, thence north 5 degrees east on said line 700 feet to the place of beginning and standing in the name of William D. Stanberry.

The following described real estate, situated in Trimble township, Athens County Ohio and known as being a part of land recorded to J. S. Stockham, fraction 12, town 11 range 14 of the Ohio Company's Purchase, beginning at the northeast corner of land of J. W. Bryson, said corner in the center of the fike leading from Glouster Ohio to Bishopville Ohio, thence north 45 degrees 15 minutes east 60 feet on the fike, thence south 64 degrees east 118 feet to lands of J. W. Bryson, thence north 64 degrees west to the place of beginning, containing 16-100 of an acre, more or less and standing in the name of C. D. Eddy.
