DESCRIPTION OF A 0.657 ACRE TRACT

Situated in the Village of Glouster, Fractions 1 and 6, Section 15, Town 11, Range 14, Trimble Township, Athens County, Ohio, and being all of Tract 1 and a part of Tract 3 and Tract 4 described in Volume 306 Page 1601 Official Record of Athens County and being more particularly described as follows:

Commencing at the Rail Monument found in the North line of Fraction 1 in the Easterly line of Glouster Corporation and at the Northeast corner of the aforementioned Tract 1 of the Grantor's tracts:

thence, following the Grantor's tract 1, South 25 degrees 58 minutes 54 seconds West, a distance of 229.87 feet to an iron pin found;

thence, South 66 degrees 36 minutes 54 seconds West, a distance of 160.00 feet to an iron pin found, said iron pin found being the POINT OF BEGINNING of the following described tract; thence, North 29 degrees 55 minutes 00 seconds West, a distance of 276.76 feet to an iron pin found at the Southwest corner of the Grantor's tract 3;

thence, leaving said tract 1 and following tract 3, North 51 degrees 40 minutes 49 seconds East, a distance of 209.16 feet to an iron pin found;

thence, leaving said tract 3 on a random line, South 4 degrees 02 minutes 06 seconds West, a distance of 370.49 feet to the POINT OF BEGINNING; said described tract containing 0.657 acre (28,632.976 square feet), All of the aforementioned tract 3, 0.020 acres out the aforementioned tract 4 and 0.448 acres out of the aforementioned tract 1, 0.448 acres in Fraction 1 and 0.209 acres in Fraction 6.

Bearings are based on a previous Survey of the West line of the Grantor's tracts and are used to denote angles only.


