As restrictions and conditions of the dedication of the lands contained within this plat and as part of the consideration of the incorporation of like covenants in all conveyances of the lots in this addition, all grantees of any of said lots for themselves their heirs, executors, administrators and assigns for the use and benefit of all grantors, their heirs, executors, administrators and assigns and every other person who shall or may become the owner of, or have any title derived immediately or remotely from, through or under said grantors, their heirs, executors, administrators or assigns to any lot or parcel of land situated in said addition are bound by the following restrictions and agreements in so far as the same relate to the lot or lots of such owner or owners.

- A. The owner or owners of lots Nos. 3157, 3158 and 3159 shall be mutually bound to maintain and keep in a state of repair, and enjoy equal rights of ingress and egress over the right-of-way easement as shown on the plat hereof.
- B. The owner or owners of lots Nos. 3160, 3161, 3163, 3164, 3165 shall be mutually bound to maintain and keep in a state of repair, and enjoy equal rights of ingress and egress over the right-of-way easement as shown on this plat.
- C. As to the cost of the construction and repair of said two easements each of said lots through which said easements pass is to be known as a separate segment thereof and such costs of such construction and repair as to each separate segment is to be borne equally by the owners of the lots enjoying the use and benefit thereof.

Provided that at any time any lot owner ceases to use and enjoy such easement appurtenant to such lot such owner is not to be further bound as to said provisions of maintenance and repair thereof subsequent to such cessation of use but such lot shall continue to be subject to said easement use hereinbefore set forth.

No building may be erected on any of the lots in said addition other than for residence purposes only or incident thereto, and only one single or double residence shall be erected, re-erected or maintained upon each lot in said addition, the erection of any apartment house is not permitted. No single house is to be erected on any of said lots the cost of which at current prices during the month of June, 1953, would, exclusive of land, be less than \$12,000.00 and no double house shall be erected on any of said lots the cost of which at current prices during the month of June, 1953, would, exclusive of land, be less than \$20,000.00.

No livestock other than personal household pets shall be kept by any one on any lot of this addition.

No garage, trailer or other temporary building shall be erected, placed upon, maintained or re-erected and used for residence purposes, either temporary or permanently on any of said lots.
