

PROCEEDINGS TO DETACH TERRITORY FROM THE VILLAGE OF JACKSONVILLE, OHIO.

PETITION, ORDINANCE & RESOLUTION.

TO THE COMMISSIONERS OF ATHENS COUNTY, OHIO.

We, the undersigned freehold electors holding lands in that portion of the territory within the municipality of Jacksonville, Ohio, described below, do hereby petition the commissioners of Athens County, Ohio, to detach from the said Village of Jacksonville said territory, which is described as follows:

Beginning at the northwest corner of Section 7 on the north line of Jacksonville corporation; thence east 870 feet to the north corner of lot 39; thence south 19 degrees west 6.39 chains to the southwest corner thereof; thence south 86 degrees east 460 1/2 feet along the south lines of lots 39 and 35 to the north line of an alley; thence along said alley south 47 degrees west 120 feet and south 11 degrees east 137 feet to the south line of Main Street; thence south 79 degrees west 200 feet along the south line of said street to the west line of First Street; thence south 11 degrees east 251 feet along the west line of First Street to the center of Sunday Creek; thence down the center of Sunday Creek to where it intersects the east line of the right of way of the K. & M. R.R.; thence southwesterly along said right of way until it intersects the south line of Section 7; thence west along the south lines of section 7 and 13 to the middle of the Millfield-Trimble road; thence northerly in the middle of said road to the north line of Section 13; thence east 210 feet to the place of beginning.

Said territory is contiguous to Trimble Township. Plat of said territory hereto attached.

At a regular meeting of the Council of the Village of Jacksonville, Athens County, Ohio, held May 1st., 1919, member of Council Campbell presented and ordinance and is in title as follows, and being ordinance No. 59.

"An ordinance assenting to the detachment of certain territory from the Village of Jacksonville, Ohio."

Moved by Kellner, seconded by Kempton that above ordinance be placed on its first reading. All yeas, no nays, motion carried. Thereupon said ordinance was read for the first time according to law.

Moved by Gibbs, seconded by Burdiss, that rules requiring reading of an ordinance on three separate dates be suspended and the above ordinance be placed on its second reading by title only. All Yeas, No nays, motion carried. Thereupon said ordinance was read for the second time according to law.

Moved by Kellner seconded by Kempton that rules requiring reading of an ordinance on three separate dates be suspended and the above ordinance be placed on its third reading and final passage. All yeas, no nays, motion carried. Thereupon said ordinance was read for the third time according to law.

Moved by Gibbs, seconded by Kellner that the above ordinance be adopted as read. Yeas, Campbell, Gibbs, Kellner, Burdiss, Maillard and Kempton, nays, none. The Mayor then declared said ordinance passed May first, 1919, and is in words and figures as follows, and attached to page No. 210 of Village records.

ORDINANCE NO. 59.

An ordinance assenting to the detachment of certain territory from the Village of Jacksonville, Ohio.

Be it ordained by the council of the Village of Jacksonville, State of Ohio: Section 1.- That the Council of the said Village of Jacksonville do hereby assent to the detachment of the incorporated limits of said Village, the following described territory to-wit:-

Beginning at the northwest corner of Section 7 on the north line of Jacksonville corporation; thence east 870 feet to the north corner of lot 39; thence south 19 degrees west 6.39 chains to the southwest corner thereof; thence south 86 degrees east 460 1/2 feet along the south lines of lots 39 and 35 to the north line of an alley; thence along said alley south 47 degrees west 120 feet and south 11 degrees east 137 feet to the south line of Main Street; thence south 79 degrees west 200 feet along the south line of said street to the west line of First Street; thence south 11 degrees east 251 feet along the west line of First Street to the center of Sunday Creek; thence down the center of Sunday Creek to where it intersects the east line of the right of way of the K. & M. R.R.; thence southwesterly along said right of way until it intersects the south line of Section 7; thence west along the south lines of section 7 and 13 to the middle of the Millfield-Trimble road; thence northerly in the middle of said road to the north line of Section 13; thence east 210 feet to the place of beginning.

Section 11.- This ordinance shall take effect and be in full force from and after the earliest period allowed by law.

WHEREAS, the majority of the freehold electors holding lands in that portion of the territory within the municipality of Jacksonville, Ohio, as described in petition of said freehold electors heretofore filed with the Board of Commissioners of Athens County, Ohio, praying that said territory described in said petition to be detached from the incorporated limits of the said Village of Jacksonville, Ohio, and

WHEREAS, said board finds that said petition is signed by a majority of the aforesaid freehold electors, and

WHEREAS, a plat of said territory has been filed with said board, and

WHEREAS, the council of the said Village of Jacksonville, Ohio, has duly passed an ordinance indorsing and accepting said petition, and

WHEREAS, the said Village of Jacksonville has no bonded indebtedness to be apportioned between the said village and Township of Trimble to which said territory will revert.

Be it resolved by the Board of Commissioners of Athens County, Ohio, that said territory, as described in said petition be and the same is hereby detached from the said Village of Jacksonville, Ohio.

On motion of commissioner Mundew and seconded by commissioner Sawyer that said above resolution be adopted on roll call, commissioners, Porter, Sawyer and Mundew voted yea, thereupon the president declared said motion carried and said resolution adopted.
