Situated in Outlots 24,25 and 35, Fraction 12, Section 10, Town 10, Range 15, Lee Township, Athens County, Ohio and described as follows:

Commencing at the northeast corner of said Fraction 12; thence on an assumed bearing North 85°59'48" West 1,558.93 feet to a point; thence South 04°00'12" West 310.00 feet to a found iron pin at the northwest corner of a 6.95 acre tract described in Volume 18 Page 717 of the Athens County Official Deed Records, thence along the north line of said 6.95 acre tract South 84°21'49" East 512.80 feet to a point, THE TRUE POINT OF BEGINNING; thence continuing along the north line of said 6.95 acre tract South 84°21' 49" East (passing a found iron pin at 557.39 feet) for a total distance of 607.39 feet to a point in Athens County Road 12; thence along said road and the east line of said 6.95 acre tract South 11°05'05" East 266.46 feet to a point at the southeast corner of said 6.95 acre tract; thence along the east line of a 5.11 acre tract described in Volume 90 Page 190 of the Athens County Official Deed Records South 11°34'28" East 117.08 feet to point; thence leaving said road on a random line the following bearings and distances:

- 1) North 84°58'11" West (passing a set iron pin at 45.00 feet) for a total distance of 582.94 feet to a set iron pin; thence
- 2) North 02°44'28" West 170.70 feet to a set iron pin on the north line of said 5.11 acre tract and south line of the aforesaid 6.95 acre tract; thence along the north line of said 5.11 acre tract and the south line of said 6.95 acre tract North 85°01'40" West 90.00 feet to a set iron pin; thence on a random line North 02°44'28" West 265.50 feet to the point of beginning and containing 5.942 acres, there being 3.729 acres out of 6.95 acre tract described in Volume 18 Page 717 of the Athens County Official Deed Records and 2.213 acres out of a 5.11 acre tract described in Volume 90 Page 190 of the Athens County Official Deed Records. The above described 5.942 acre tract is further defined as consisting of 3.972 acres in Outlot 24 and 1.970 acres in Outlot 25. 
