## LEGAL DESCRIPTION FOR Carl E. & Irene M. Shafer 14.634 ACRE TRACT

Beginning at an aluminum monument, set by Leonard Swoyer on June 27, 1990 for the Athens County Engineer's office, at the northwest corner of the northeast quarter of Section 16; thence South 86° 13′ 08" East, along the section line, a distance of 324.81 feet to an iron pin found with Leonard Swoyer's ID cap #6765, said pin being the TRUE POINT OF BEGINNING for this description;

Thence continuing along the section line, South 860 13' 08" East, a distance of 457.72 feet to a railroad spike set in the center of State Route 681;

Thence along the center of State Route 681 the following four courses:

South 28<sup>O</sup> 14' 15" East, a distance of 113.35 feet to a point,

South 29<sup>O</sup> 19' 12" East, a distance of 343.86 feet to a point,

South 32<sup>O</sup> 17' 34" East, a distance of 89.13 feet to a point,

South 37<sup>O</sup> 56' 21" East, a distance of 69.32 feet to a railroad spike set at the northwest corner of Carl and Jacqueline Johnson's tract (Vol. 252, Pg.

Thence leaving said road and running South 030 46' 52" West, along Johnson's west line a distance of 393.06 feet to an iron pin set, passing an iron pin set at 53.08 feet;

Thence North 860 30' 10" West, a distance of 811.98 feet to an 2" iron pipe found in the east line of Floyd O. and Sally Martin's tract (Vol. 310, Pg.

Thence North  $04^{\rm O}$  16' 19" East, along Martin's east line, a distance of 905.06 feet to the true point of beginning passing a 1-1/2 inch iron pipe at 525.87 feet and a 1 inch iron pin at 900.90 feet.

Containing 14.634 acres and being subject to all legal right-of-ways and easements.

A plat of survey is attached hereto and made a part hereof.

Basis of Bearing for this description is True North as established by the Certified Land Corner Restoration for the north line of Section 16 by Leonard Swoyer on June 27, 1990.

All iron pins set for this survey are 5/8" inch rebar with a numbered cap.
