Commencing at the northeast corner of the southeast quarter of the northeast quarter of said Section 2; thence along the north line of said southeast quarter of the northeast quarter North 85 degrees 32 minutes 08 seconds West, a distance of 527.34 feet to an iron pin (calculated location), the northeast corner of a 5.44 acre tract described in Volume 48 Page 696 of the Athens County Official Deed Records; thence along the east line of said 5.44 acre tract South 5 degrees 28 minutes 46 seconds West, a distance of 423.41 feet to a found iron pin at the southeast corner of said 5.44 acre tract and the grantor's northeast property corner, THE TRUE POINT OF BEGINNING; thence along the grantor's east property line South 5 degrees 28 minutes 43 seconds West, a distance of 228.28 feet to an iron pin set; thence along an arbitrary line the following four bearings and distances: 1) North 81 degrees 03 minutes 42 seconds West, passing through an existing utility pole at 18.41 feet, for a total distance of 116.70 feet to an iron pin set; thence 2) North 46 degrees 25 minutes 46 seconds West, a distance of 51.29 feet to an iron pin set; thence 3) North 62 degrees 12 minutes 59 seconds West, a distance of 42.98 feet to an iron pin set; thence 4) North 4 degrees 52 minutes 40 seconds East, a distance of 185.46 feet to an iron pin (calculated location) on the grantor's north property line and the south line of property line and the south line of said 5.44 acre tract South 81

EASEMENT "A"

DESCRIPTION OF A 25 FOOT WIDE EASEMENT FOR INGRESS AND EGRESS

Situated in the southeast quarter of the northeast quarter of Section 2, Town 10, Range 15, Village of Albany, Lee Township, Athens County, Ohio and described as follows:

Commencing at an iron pin (calculated location) at the grantor'southeast property corner at the northeast corner of Lot 9 of the Louise Gilkey Subdivision , THE TRUE POINT OF BEGINNING; thence along the grantor's south property line and the north line of said Lot 9 on an assumed bearing North 84 degrees 10 minutes 35 seconds West, a distance of 115.24 feet to an iron pin (calculated location) at the grantor's southwest property corner and the northwest corner of said Lot 9 and on the east side of the right of way of the cul de sac in said Louise Gilkey Subdivision; thence along the east side of said cul de sac on a non-tangential curve to the to the left a distance of 43.88 feet, said curve has a radius of 40.00 feet, a central angle of 62 degrees 51 minutes 05 seconds, and a chord which bears North 54 degrees 15 minutes 39 seconds West a distance of 41.71 feet to an iron pin (calculated location) on the southerly property line of a 5.44 acre tract described in Volume 48 Page 696 of the Athens County Official Deed Records and the grantor's westerly property line; thence leaving the east right of way line of said cul de sac on an arbitrary line North 89 degrees 12 minutes 04 seconds East, a distance of 36.40 feet to a point; thence along a line which is parallel and 25.00 feet distant to the north line of aforesaid Lot 9 South 84 degrees 10 minutes 35 seconds East, a distance of 115.03 feet to a point on the grantor's east property line; thence along the grantor's east property line South 5 degrees 19 minutes 42 seconds West, a distance of 25.00 feet to the POINT OF BEGINNING and containing 0.073 acre, and being a part of Lot 8 as described in Volume 259 Page 555 of the Athens County Deed Records.

DECSCRIPTION OF A 25 FOOT EASEMENT FOR INGRSS AND EGRESS

Situated in the southeast quarter of the northeast quarter of Section 2, Town 10, Range 15, Village of Albany, Lee Township, Athens County, Ohio and described as follows:

Commencing at an iron pin (calculated location) at the northeast corner of Lot 9 of the Louise Gilkey Subdivision and the southeast corner of a tract of land described in Volume 259 Page 555 of the Athens County Deed Records and on the grantor's west property line; thence along the grantor's west property line North 5 degrees 19 minutes 42 seconds East, a distance of 25.00 feet to a point; thence along an arbitrary line the following two bearings and distances: 1) South 84 degrees 10 minutes 35 seconds East, a distance of 132.70 feet to a point; thence 2) South 4 degrees 52 minutes 40 seconds West, a distance of 25.00 feet to a point; thence along a line which is the prolongation of the north line of aforesaid Lot 9 North 84 degrees 10 minutes 35 seconds West, a distance of 132.90 feet to the POINT OF BEGINNING and containing 0.076 acre, and being a part of a tract of land described in Volume 53 Page 505 of the Athens County Official Deed Records.

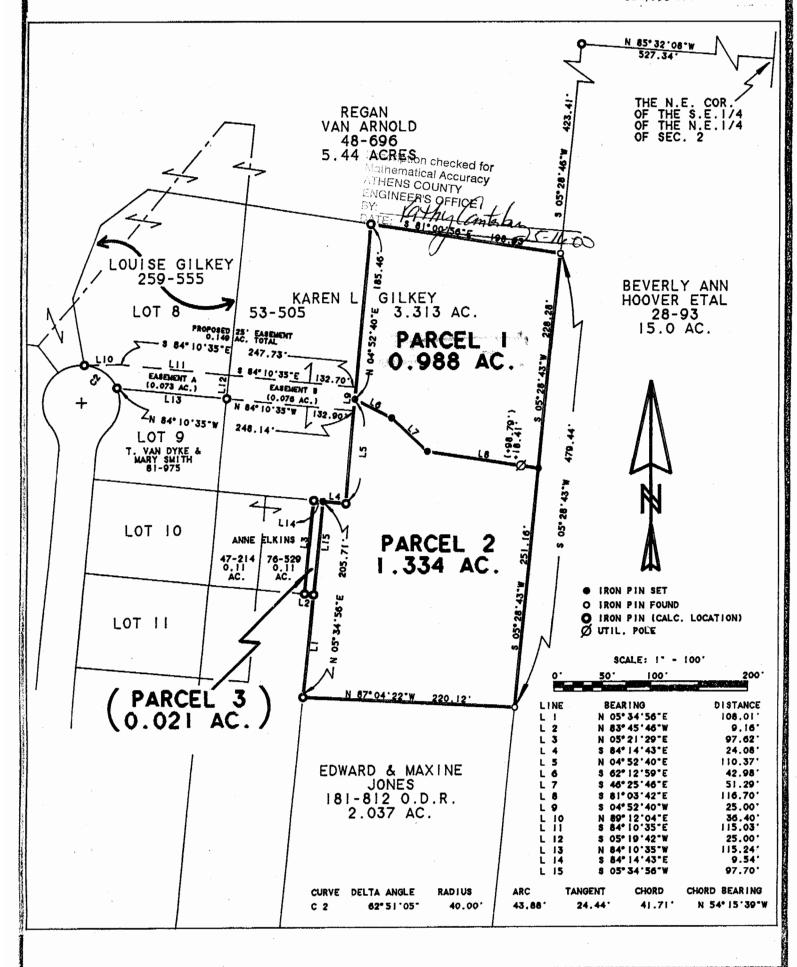
