Commencing at a point in Township road 10, bearing North 76 degrees 19 minutes 20 seconds West, a distance of 1077.53 feet from a Monument found at the North-east corner of Section 22, said point being the North-east corner of a 2.20 acre tract described in volume 185, page 106, Official Records of Athens County;

thence, leaving said road and following the East line of the aforementioned 2.20 acre tract, South 40 degrees 28 minutes 37 seconds West, a distance of 392.48 feet to an iron pin found, passing an iron pins found at 30.00 feet; said point being the POINT OF BEGINNING;

thence, leaving said tract and on a random line, South 57 degrees 55 minutes 56 seconds West, a distance of 463.20 feet to an iron pin set;

thence, North 14 degrees 22 minutes 07 seconds West, a distance of 312.04 feet to an iron pin set;

thence, North 54 degrees 26 minutes 31 seconds East, a distance of 338.06 feet to an iron pin set, said point being the Western most corner of the aforementioned 2.20 acre tract;

thence, following the South line of said tract, South 37 degrees 37 minutes 17 seconds East, a distance of 319.35 feet to a point to the POINT OF BEGINNING and containing 2.82 acres and to be continuous and contiguous with the aforementioned 2.20 acre tract, 1.67 acres being in Section 22 and 1.15 acres being in Section 23.
