Thence continuing with a new line through the grantor's land, North 00 degrees 12 minutes 37 seconds West passing through a 5/8" X 30" iron pin with a plastic identification cap set at 847.87 feet, going a total distance of 877.87 feet to a point in the center of Township Road 15A;

Thence along the center of Township Road 15A, North 83 degrees 52 minutes 08 seconds East a distance of 50.27 feet to the principle place of beginning containing 6.310 acres, more or less, and subject to the right-of-way of Township Road 15A and all easements of record.


All 5/8" X 30" iron pins with plastic identification caps set are stamped "Seymour & Associates".




