Tract 1: Commencing at a set iron pin at the Southwest corner of a 64 acre tract described in Volume 301 Page 220 of the Athens County Deed Records; thence along the South property line of said 64 acre tract on an assumed bearing South 83 degrees 49 minutes 45 seconds East (passing set iron pins at 530.30 feet 961.37 feet) for a total distance of 1463.14 feet to the TRUE POINT OF BEGINNING, a set iron pin; thence North 09 degrees 54 minutes 33 seconds East (passing a set iron pin at 455.15 feet) for a total distance of 747.73 feet to a set iron pin; thence South 73 degrees 49 minutes 39 seconds East (passing set iron pins at 98.63 feet, 167.08 feet and 193.48 feet) for a total distance of 215.22 feet to a point, the East property line of aforementioned 64.0 acre tract and the West property line of a 33 acre tract recorded in Volume 298 Page 288 of the Athens County Deed Records; thence along said property line South 06 degrees 25 minutes 57 seconds West 708.77 feet to a point on the North property line of a 11.63 acre tract described in Volume 353 Page 333 of the Athens County Deed Records; thence along said North property line North 83 degrees 49 minutes 45 seconds West 257.46 feet to a set iron pin and the point of beginning containing 3.9308 acre and being part of a 64 acre tract described in Volume 301 Page 220 of the Athens County Deed Records.

It is the intention of the Grantor to leave a 13 feet perpetual easement for ingress and egress purposes over and across the above described 3.9308 acre tract; the center line of said easement is described as follows; Commencing at a set iron pin the Northwest corner of said 3.9308 acre tract; thence along the West property line of said tract South 09 degrees 54 minutes 33 seconds West 121.27 feet to the true point of beginning and center line of said easement; thence along the center line South 61 degrees 13 minutes 41 seconds East 237.28 feet to the center line of the presently existing right of way that is recorded in Volume 298 Page 288 of the Athens County Deed Records.
