1. N 87° 40' 45" E, 530.64 feet to a concrete post and
2. N 03° 09' 47" W, 474.28 feet to a spike in the center of Township Road No. 13; thence with the center of said Township Road N 86° 50' 13" E, 453.17 feet to a spike; thence with two new lines through the tract of which this is a part

1. S 03° 09' 47" E, 700.86 feet to an iron pin passing an iron pipe at 25.00 feet, and
2. S 87° 40' 45" W, 1010.89 feet to the place of beginning containing 10.005 acres more or less and subject to all legal highways and easements.

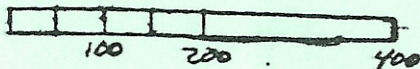


Match Line "A"
