Description of a tract of land situate Ohio Company Purchase, Town 10, Range 15, Fraction 1 and Fraction 31, Lee Township, (Auditor's Section 10), Athens County, Ohio, and being more fully described as follows:

Beginning at an iron pin found at the northeast corner of said Fraction 31;

- 1.) Thence S03°12'10"W 1140.15 feet along a common boundary to Borkholder 566-2511, Laughlin 234-105, Stack 566-2286, and Tribe 267-1671 to an iron pin found, passing iron pins found at 298.89 feet and 871.15 feet;
- 2.) Thence S86°06'44"E 325.52 feet along a common boundary to Tribe 267-1671 to an iron pin found;
- 3.) Thence S86°21'17"E 752.71 feet along said common boundary to a point in the center of County Road 10, Baker Rd, passing an iron pin found at 721.30 feet;
- 4.) Thence S39°39'46"W 61.82 feet to a point in the center of County Road 10;
- 5.) Thence N86°21'17"W 1038.72 feet over the lands of Borkholder 571-2178 to an iron pin set, passing an iron pin set at 30.00 feet;
- 6.) Thence S00°07'48"W 165.83 feet along a common boundary to Borkholder 571-2148 and Borkholder 566-2511 to an iron pin set;
- 7.) Thence S00°07'48"W 182.51 feet along said common boundary to an iron pin found;
- 8.) Thence S85°15'48"W 380.56 feet over the lands of Borkholder 566-2511 to an iron pin set;
- 9.) Thence N44°22'56"W 763.33 feet over said lands to an iron pin set, passing an iron pin set at 282.37 feet;
- 10.) Thence N20°36'37"E 412.07 feet over said lands to an iron pin set;
- 11.) Thence N84°55'13"W 723.53 feet over said lands to an iron pin set;
- 12.) Thence N03°52'58"E 681.77 feet along a common boundary with Ennis 358-181 to an iron pin set;
- 13.) Thence S85°58'51"E 1510.96 feet along a common boundary with Ennis 358-181 and Bean 294-337 to the point of beginning containing a total of 40.352 acres.

- 2.) Thence N03°45'41"E 1042.94 feet along the center of said driveway to a point;
- 3.) Thence along a curve to the left having a radius of 46.97 feet and length of 74.26 feet with a chord bearing of N41°32'14"W and chord distance of 66.77 feet to a point in the center of said driveway;
- 4.) Thence S85°15'48"W 380.56 feet a point in the center of said driveway and being the terminus of the Easement.

Subject to all easements, rights-of-way, and covenants and agreements of record.

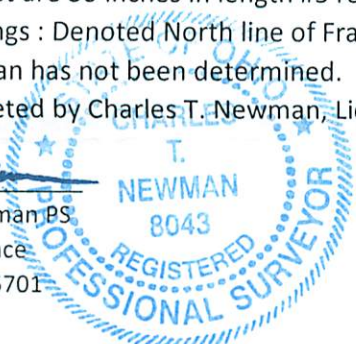
