Commencing at a set iron pin on the south line of Alton Street at the northeast corner of Lot 46 of the Village of Albany and a tract (Tract I) conveyed to Richard G. and Bernita I. Stotts (386/39) at the northwest corner of Lot 47 of the Village of Albany and a tract conveyed to Robert L. and Sally Jo Wiley (399/2146 O.R.) THE TRUE POINT OF BEGINNING; thence along the north line of Lot 47 and Lot 48 of the Village of Albany and north line of said Wiley Tract (399/2146 O.R.) and the south line of said Alton Street

North 87 Degrees 00 Minutes 00 Seconds East a distance of 86.55 feet to a set iron pin ;

thence along a new line the following two bearings and distances:

- 1) South 03 Degrees 45 Minutes 00 Seconds West a distance of 48.54 feet to a set iron pin ; thence
- 2) South 33 Degrees 06 Minutes 36 Seconds West a distance of 40.06 feet to a set iron pin

on the southerly line of said Wiley tract (399/2146 O.R.) and Lot 65 of the Village of Albany on the northerly line of a tract conveyed to the General Telephone Company of Ohio (247/579) and northerly line of Lot 66 of the Village of Albany; thence along the southerly line of said Wiley tract (399/2146 O.R.) and Lot 65 of the Village of Albany and the northerly line of said General Telephone Company of Ohio tract (247/579) and northerly line of Lot 66 of the Village of Albany

North 56 Degrees 30 Minutes 19 Seconds West a distance of 13.00 feet to a set iron pin

on the south line of aforesaid Lot 47 at the northwest corner of Lot 65; thence along the westerly line of said General Telephone Company of Ohio tract (247/579), the northerly line of said Lot 66 and the south line of Lot 47 and southerly line of aforesaid Wiley tract (399/2146 O.R.)

North 85 Degrees 53 Minutes 55 Seconds West a distance of 55.02 feet to a set iron pin

at the southwest corner of Lot 47 and said Wiley tract (399/2146 0.R.) and southeast corner of aforesaid Stotts tract (Tract I) (386/39) and Lot 46; thence along the west line of said Lot 47 and Wiley tract (399/2146 0.R.) and the east line of said Lot 46 and Stotts tract (Tract I) (386/39)


North 03 Degrees 45 Minutes 00 Seconds East a distance of 66.50 feet to the point of beginning

Note: Unless otherwise noted, all set iron pins are 5/8-inch diameter rebar and 30 inches in length and capped with a yellow plastic identification marker inscribed " TOM TRANTINA RLS-8320."

Subject to all deeds and right of ways, reservations, restrictive and protective covenants, utility easements and oil, gas and mineral leases of record in the chain of title in Athens County.



Plat of SURVEY DF A 0. 138 ACRE TRACT


