Situated in the southwest quarter of Section 1, Town 4, Range 13, Lodi Township, Athens County, Ohio and described as follows:

Commencing at the southwest corner of said Section 1; thence on an assumed bearing of North 30 17'04" East 1,537.99 feet to a point in the center of Athens County Road 46, THE TRUE POINT OF BEGINNING; thence continuing along the center of said Athens County Road 46 the following four bearings and distances:

- 1. South 15 43'08" West 94.01 feet to a point; thence
- 2. South 28 14'36" West 161.34 feet to a point; thence
- 3. South 40 32'38" West 192.90 feet to a point; thence
- 4. South 64 39'17" West 44.01 feet to a point; thence leaving the said Athens County Road 46 South 15 41'07" East (passing a set iron pin at 15.00 feet) for a total distance of 27.68 feet to a point; thence along the center of an existing tractor road the following twelve bearings and distances:
- 1. South 66 36'54" East 34.45 feet to a point; thence
- 2. South 24 35'32" East 18.87 feet to a point; thence
- 3. South 01 50'19" East 265.84 feet to a point; thence
- 4. South 48 12' 33" East 90.60 feet to a set iron pin; thence
- 5. South 84 36'28" East 255.23 feet to a point; thence
- 6. North 83 11'34" E 65.24 feet to a point; thence
- 7. North 74 19'58" East 180.74 feet to a point; thence
- 8. North 78 23'30" East 86.91 feet to a point; thence
- 9. South 81 21'30" East 153.41 feet to a point; thence
- 10. South 66 49'27" East 248.07 feet to a point; thence
- 11. South 49 51'57" East 196.03 feet to an iron pin set; thence
- 12. North 80 26'17" East 209.24 feet to an iron pin set; thence along a random line South 83 42'33" East (passing a set iron pin at 428.38 feet) for a total distance of 463.57 feet to a point in Shade Creek at the grantor's east property line, thence along said creek and along the grantor's east property line North 01 04'48" East 273.78 feet to a point at the grantor's northeast property corner at the mouth of a ravine; thence leaving the creek, following an existing ravine and along the grantor's north property line North 73 20'37" West 652.08 feet to a point; thence leaving the existing ravine North 13 20'30" West 203.29 feet to a stone found at the southeast corner of a 45.02 acre tract described in Volume 94 Page 134 of the Athens County Official Records (witness a found iron pin at North 01 36'48" West 5.80 feet); thence along the grantor's north property line and along the south line of said 45.02 acre tract the following two bearings and distances:
- 1. South 87 16'20" West 396.93 feet to a found iron pin (witnessed a found stone which bears North 78 56'00" West 1.22 feet); thence
