Situated in Section 24, Lodi Township, Town 4, Range 13, Athens County, Ohio and described as follows:

Commencing at the southeast corner of said Section 24; thence along the south line of said section on an assumed bearing of South 90°00'00" West 509.47 feet to a point in Athens County Road 75, THE TRUE POINT OF BEGINNING; thence leaving said road and continuing along said south line of Section 24 South 90°00'00" West (passing a set iron pin at 15.00 feet) for a total distance of 359.09 feet to an existing fence corner post at the southwest corner of a 19.74 acre tract described in Volume 225 Page 170 of the Athens County Deed Records; thence leaving said section line and along the west line of said 19.74 acre tract North 00°58'51" East (passing a set iron pin at 298.93 feet) for a total distance of 313.93 feet to a point in aforesaid Athens County Road 75: thence along said road the following five bearings distances:

- 1) North 87°47'18" East 85.29 feet to a point; thence
- 2) South 75°53'09" East 72.79 feet to a point; thence
- 3) South 50°50'24" East 90.46 feet to a point; thence
- 4) South 26°54'38" East 147.54 feet to a point; thence
- 5) South 28°50'27" East 126.42 feet to the point of beginning and containing 1.920 acres and being a part of a 19.74 acre tract described in Volume 225 Page 170 of the Athens County Deed Records.

Note: Unless otherwise noted all set iron pins are 5/8 inch in diameter and 30 inches in length and capped with a plastic identification marker scribed Leonard F. Swoyer R.L.S. 6765.


