Tract 1: 21.695 Acres
part Countrytyme Land, LLC Parcel: O.R. Book 517, Page 2091

Situated in the Township of Lodi, County of Athens, State of Ohio, and being a part of Section 25, Township 4N, Range 13W, of the Ohio Company's Purchase, and being more particularly described as follows;

Being a Survey of a part of a 108.167 Acre parcel conveyed to Countrytyme Land, LLC, as recorded in O.R. Book 517, Page 2091, in the Athens County Deed Records, being part of Auditor's P.P.N. J01-00100308-00, and further described as follows;

Commencing at a ¾" o.d. iron pipe found w/cap stamped "O.D.O.T." located at 102.25 Left of centerline Station 41+000.000 of U.S. Route 33, as recorded on Plan No. ATH-33-40.981(25.46), sheets 1-13, on record at the Ohio Department of Transportation District 10 Office, Marietta, Ohio, and being the Northwest corner of a parcel conveyed to James L. Baschak, as recorded in O.R. Book 401, Page 1986, and being on the South line of a parcel conveyed to Keith & Linda Mullett, as recorded in O.R. Volume 497, Page 818: said pin bears S 86°44'52" E 363.78 from the Northwest corner of Section 25 (per O.D.O.T. Plan);

Thence, S 86°20'54" E 928.15 feet with the North line of Section 25, the same being the North line of said parcel conveyed to Bashak (O.R.401,Pg.1986), also being the South line of said parcel conveyed to Mullett (O.R.497,Pg.818), to an iron pin set marking the Northwest corner of said 108.167 Acre parcel conveyed to Countrytyme Land, LLC (O.R.517,Pg.2091) of which this description is a part, and being the **PRINCIPLE PLACE OF BEGINNING** of the **21.695 Acre** parcel herein to be described;

Thence, S 86°20'54" E 1041.40 feet continuing with the North line of Section 25, the same being the South line of said parcel conveyed to Mullett (O.R.497,Pg.818), also being the North line of said parcel conveyed to Countrytyme Land, LLC (O.R.517,Pg.2091), of which this description is a part, to a railroad spike set in the centerline of Possum Hollow Road (T.R.68)(40' Wide);

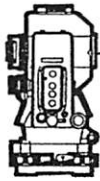
Thence, S 47°07'31" W 1941.27 feet with a line across said parcel conveyed to Countrytyme Land, LLC (O.R.517,Pg.2091) of which this description is a part, to the West line thereof, also being on the East Limited Access Right of Way of said U.S. Route 33;

Thence, N 08°26'01" W 457.87 feet with the West line of said parcel conveyed to Countrytyme Land, LLC (O.R.517,Pg.2091) of which this description is a part, the same being the East Limited Access Right of Way Line of U.S.Route 33, to a ¾" o.d. iron pipe found w/cap stamped "O.D.O.T." marking Station 41+581.726/247.82' left;

Thence, N 15°58'40" W 164.64 feet continuing with the West line of said parcel conveyed to Countrytyme Land, LLC (O.R.517,Pg.2091) of which this description is a part, the same being the East Limited Access Right of Way Line of U.S.Route 33, to a ¾" o.d. iron pipe found w/cap stamped "O.D.O.T." marking Station 41+535.411/241.79' left, and being the Southeast corner of said parcel conveyed to Baschak (O.R.401,Pg.1986);

Thence following the centerline of an abandoned Road, the same being the West line of said parcel conveyed to Countrytyme Land, LLC (O.R.517,Pg.2091), also being the East line of said parcel conveyed to Bashak (O.R.401,Pg.1986), with the following seven (7) courses and distances:

- 1) N 01°25'52" E 48.13 feet to an angle point;
- 2) N 17°25'27" E 207.66 feet to an angle point;
- 3) N 28°30'09" E 79.98 feet to an angle point;
- 4) N 52°52'25" E 146.07 feet to an angle point;
- 5) N 46°16'04" E 294.67 feet to an angle point;
- 6) N 31°29'52" E 64.09 feet to an angle point;
- 7) N 15°32'21" E 117.22 feet to the **PRINCIPLE PLACE OF BEGINNING.**

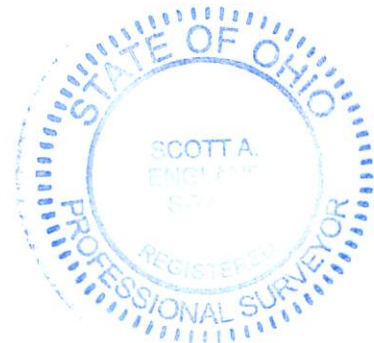

Note: All Right of Way Line along U.S. Route 33 as shown on this survey is Limited Access Right of Way.

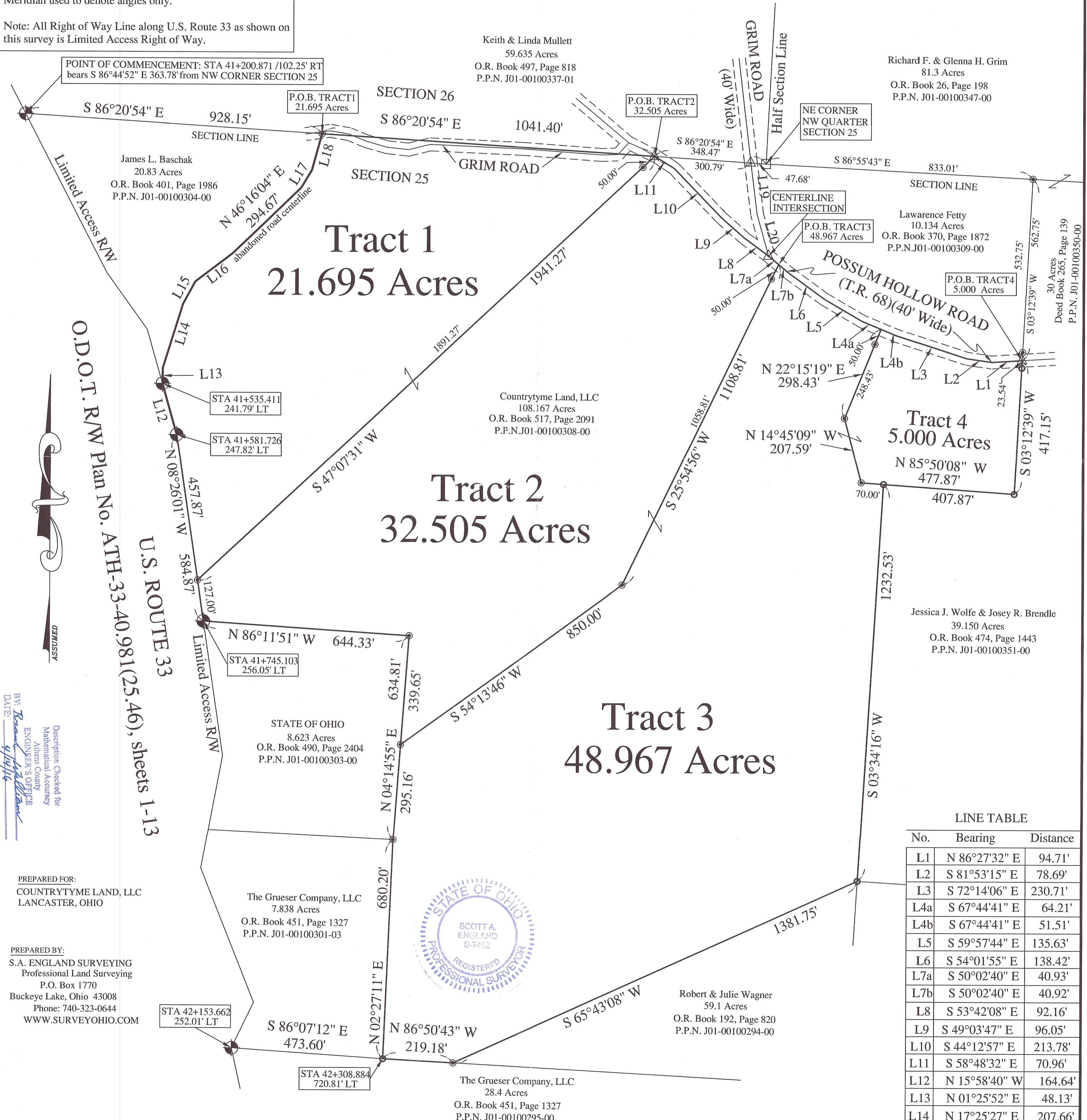
