Description of 2.587 Acres

Commencing at the southeast corner of said Section 3 of Lodi Township;

Thence N88°54'00"W 2651.52 feet along the south line of Section 3 to an iron pin set;

Thence N57°38'09"E 318.58 feet to an iron pin set;

Thence N57°38'09"E 568.85 feet to an iron pin set at the point of beginning of the tract herein described;

1.) Thence N36°17'10"W 631.59 feet over the lands of (Howard 366/2349) to an iron pin set, and continuing over said lands the following (4) courses;

2.) Thence N45°12'57"E 171.11 feet to a point in the center of County Road 47, Hogue Hollow, passing an iron pin set at 158.84 feet;

3.) Thence S37°37'30"E 431.70 feet to a point in said road;

4.) Thence S33°26'19"E 83.53 feet to a point in said road;


5.) Thence S31°06'09"E 153.55 feet to a point in said road;

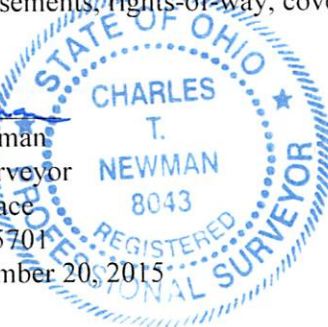

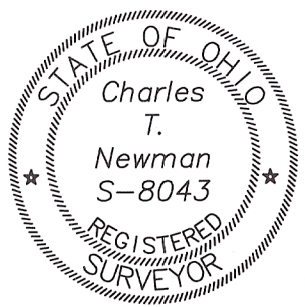

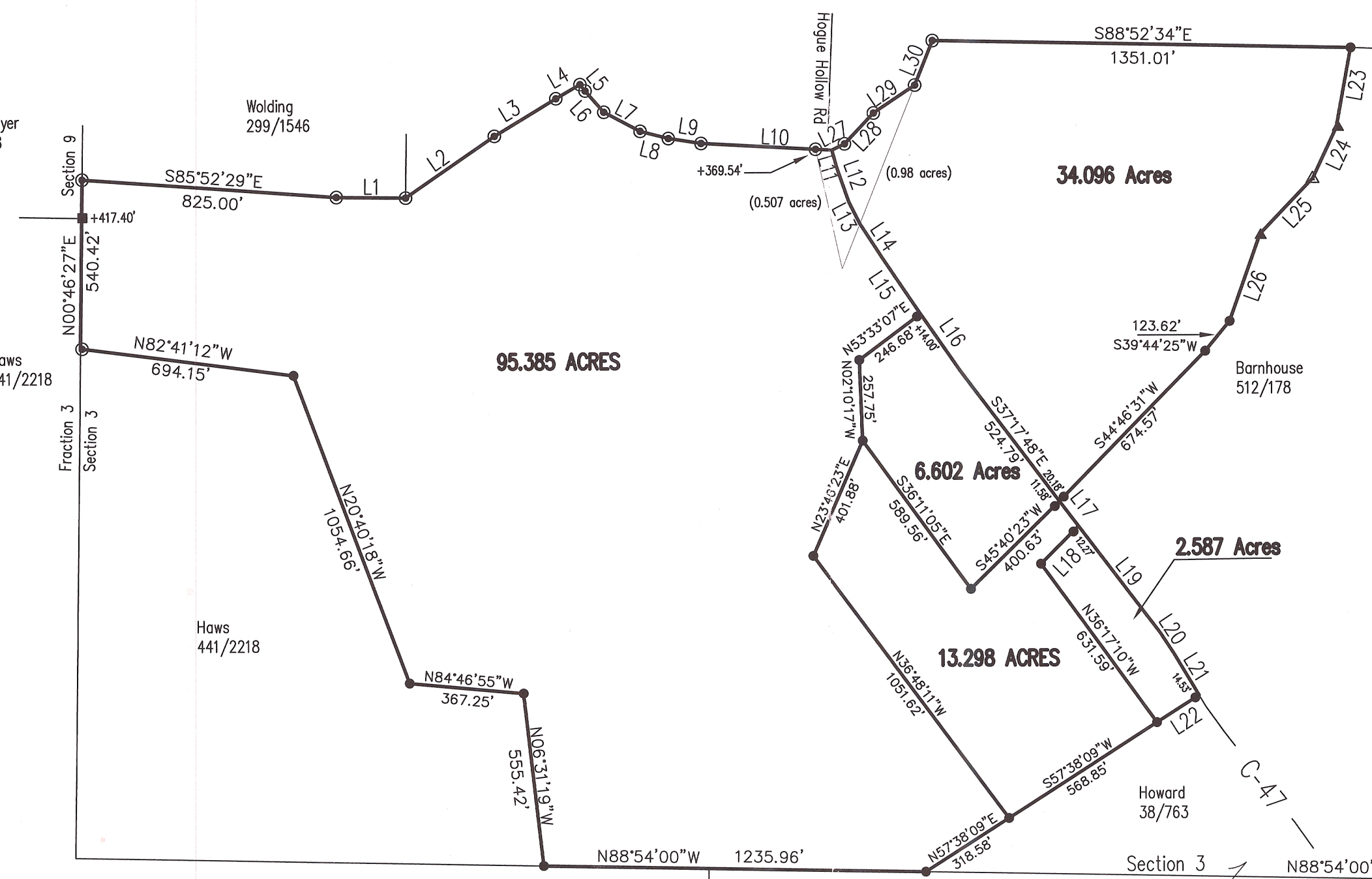
