Situated in the northwest quarter of Section 31, Town 4, Range 13, Lodi Township, Athens County, Ohio and described as follows:

Commencing at the northwest corner of said Section 31: thence along the north line of a 30.922 acre tract described in Volume 68 Page 179 of the Athens County Official Deed Records on an assumed bearing South 89 degrees 59 minutes 43 second East (passing a found iron pin at 1694.07 feet) for a total distance of 1719.07 feet to a point in the center of Athens County Road 69 and the northeast corner of said 30.922 acre tract; thence along the center of said Athens County Road 69 and the east property line of aforesaid 30.922 acre tract the following two bearings and distances South 1 degree 27 minutes 09 seconds West, a distance of 164.52 feet to a point; thence South 3 degrees 30 minutes 32 seconds West, a distance of 147.96 feet to a point, THE TRUE POINT OF BEGINNING: thence continuing along the center of said Athens County Road 69 South 1 degrees 35 minutes30 seconds West, a distance of 152.85 feet to a point; thence leaving the center of said Athens County Road 69 South 85 degrees 31 minutes 23 seconds West (passing a set iron pin at 26.59 feet) for a total distance of 280.98 feet to a set iron pin; thence South 58 degrees 41 minutes 41 seconds West, a distance of 183.28 feet to a set iron pin; thence South 74 degrees 37 minutes 43 seconds West, a distance of 443.01 feet to an iron pin\* on the easterly property line of aforesaid 30.922 acre tract; thence along the said easterly property line the following four bearings and distances 1. North 7 degrees 06 minutes 50 seconds West, a distance of 402.05 feet to an iron pin\*; thence 2. North 63 degrees 13 minutes 01 second East, a distance of 228.21 feet to an iron pin\*; thence 3. South 73 degrees 21 minutes 20 seconds East, a distance of 211.09 feet to a found iron pin; thence 4. South 83 degrees 59 minutes 07 seconds East (passing a set iron pin at 354.78 feet and a found iron pin at 484.78 feet) for a total distance of 514.78 feet to the point of beginning and containing 6.3000 acres, and being a part of a 28.58 acre tract described in Volume 75 Page 548 of the Athens County Official Deed

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.

\* Denotes iron pin was located by calculation and not measured in the field.


