LEGAL DESCRIPTION OF:
A CONTINUOUS AND CONTIGUOUS TRANSFER
BETWEEN ADJOINING PROPERTY OWNERS (*SEE NOTE BELOW)
OF A 1.853 ACRE TRACT

Situated in Section 33, Lodi Township, Town 4, Range 13, Athens County, Ohio and described as follows:

Commencing at a found one and one quarter inch pipe at the estimated and approximate southeast corner of the southwest quarter of Lodi Township Section 34; thence along the estimated south line of Section 34 and the north line of Section 33

North 86°42'01" West a distance of 1405.76 feet

to a point in Athens County Road 16 at the northwest corner of the Ernest and Shirley Kyle Living Trust (323-1277 O.R.) at the northeast corner of an 8.269 acre tract which is part of land described in Rainbow Lake of Athens County, Inc. (334/375 D.R.); thence along the west line of said Kyle Living Trust (323-1277 O.R.) and the east line of part of said tract of Rainbow Lake of Athens (334/375 D.R.)

South 03°36'14" West a distance of 1053.24 feet

to a point at the southeast corner of Christian Broadcasting Ministries (265-1218 O.R.) at the northeast corner of a landlocked tract set apart by an intervening right of way purchase for the new U.S. Route 33 (State of Ohio 332-484 O.R.) and being part of lands of aforesaid Rainbow Lake of Athens County, Inc. (334/375 D.R.) and said point is witnessed by a found two inch brass cap monument set in concrete which bears: South 86°25'20" East a distance of 1.00 foot and said point is **THE TRUE POINT OF BEGINNING;** thence along the west line of the Kyle Living Trust (323-1277 O.R.) and the east line of part of said Rainbow Lake of Athens County tract (334/375 D.R.)

South 03°36'14" West a distance of 566.00 feet

to a point on the easterly right of way of said U.S. Route 33 (State of Ohio 332-484 O.R.) and is witnessed by a found two inch aluminum capped monument which bears: South 23°01'51" East a distance of 2.11 feet; thence along said easterly right of way line of U.S. Route 33 (State of Ohio 332-484 O.R.) and the west line of said landlocked tract of Rainbow Lake of Athens (334/375 D.R.) the following two bearings and distances:

North 23°01'51" West a distance of 557.22 feet

to a found three quarter inch rebar; thence

North 30°16'58" West a distance of 81.65 feet

to a set iron pin at the new southeast corner of aforesaid Christian Broadcasting Ministries (265-1218 O.R.) created by virtue of said right of way purchase; thence along the north line of part of aforesaid tract of Rainbow Lake of Athens County (334/375 D.R.) and the south line of Christian Broadcasting Ministries (265-1218 O.R.)

South 86°25'20" East a distance of 295.32 feet

to the point of beginning and containing 1.853 acres and being part of lands described in Volume 334 Page 375 of the Athens County Deed Records.

*THE ABOVE DESCRIBED 1.853 ACRE TRACT IS TO BE CONTINUOUS AND CONTIGUOUS WITH AN ADJOINING TRACT DESCRIBED IN VOLUME 323 PAGE 1277 OF THE ATHENS COUNTY OFFICIAL DEED RECORDS.

Note 1) Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar 30 inches in length and capped with a yellow plastic identification marker inscribed: "TOM TRANTINA RLS-8320"

Note 2) All calls for adjoiners cited above and deeds shown in parenthesis are given to fulfill County Auditor and County Engineer's requirements and do not necessarily imply an acceptance of the content of said deeds or the seniority of the same.

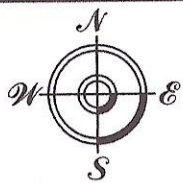

The basis of bearing for the above legal description is North 19°18'18" East between found Ohio Department of Transportation Centerline concrete monuments set at stations 37+320.57 and 37+000 (metric) and derived from a GPS survey performed by Robert Canter (a registered surveyor) in 1998 and 1999.

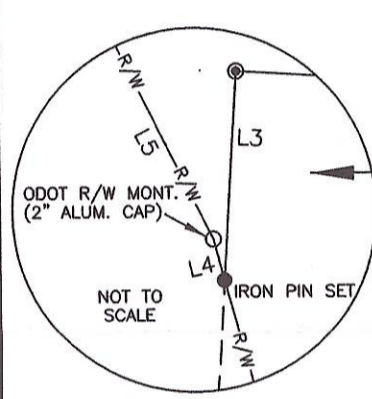

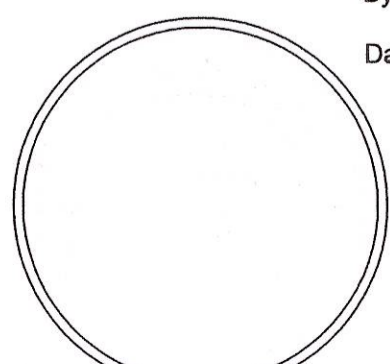
