## DESCRIPTION OF SURVEY FOR WILLIAM NOBLE

### TRACT II

Being a part of an 80 acres tract transferred to Carl Edward Puckett recorded as tract II in Deed Book 327 at Page 913, Athens County Recorder's Office, Athens County Ohio, also being a part of the West Half of the Southwest Quarter of Section 5, Township-4-North, Range-13-West, Lodi Township, Athens County, State of Ohio and more particularly described as follows:

Beginning at a 5/8" iron pin set which bears South 89°18'23" East a distance of 88.94 feet from a stone assumed to be the Northwest corner of said West Half of the Southwest Quarter, Section 5, Township-4, Range-13;

Thence South 89°18'23" East a distance of 411.26 feet to a 5/8" iron pin set;

Thence South 14°26'57" East passing thru a 5/8" iron pin set at a distance of 1354.27 feet and going a total distance of 1374.27 feet to a point in the centerline of County Road #42;

Thence along said centerline the following two courses:

1. South 72°51'00" West a distance of 106.36 feet to a point;
2. South 70°28'57" West a distance of 113.70 feet to a point;

Thence leaving said centerline North 19°07'57" West passing thru a 5/8" iron pin set at a distance of 18.75 feet and going a total distance of 75.00 feet to a 5/8" iron pin set;

Thence North 21°19'14" West a distance of 1432.29 feet to the principal point of beginning containing 10.01 acres± subject to all legal easements and rights-of-way.

Bearings were derived from a previous survey recorded in Deed Book 375 at Page 721.

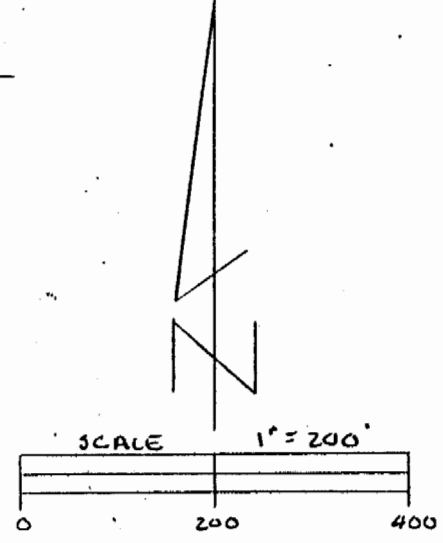
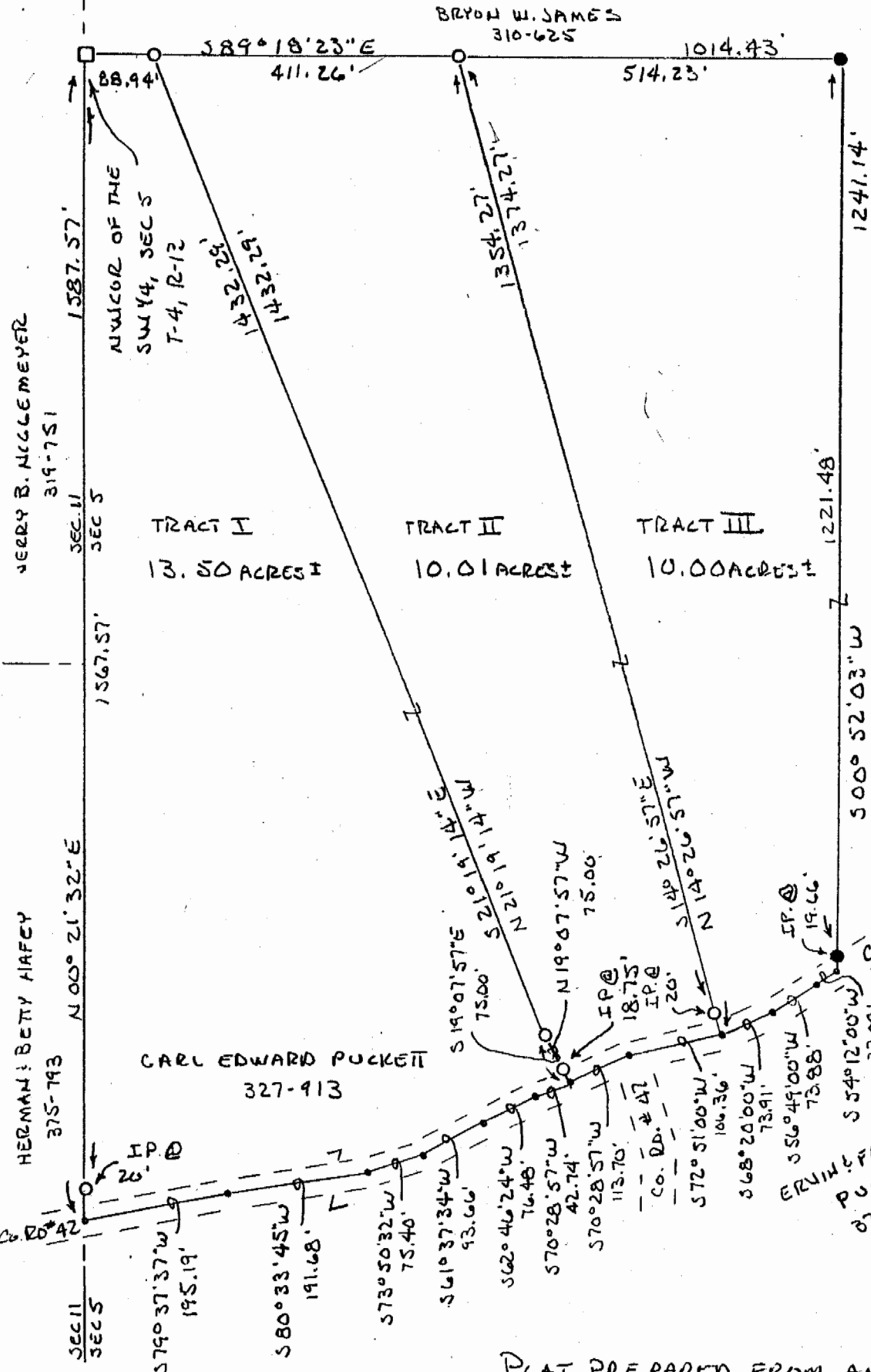
