## Description survey for Nellie Fultz

Being a part of a tract transferred to Albert C. and Nellie G. Fultz as recorded in Official Records Volume 173 at page 186 Athens County Recorder's Office, Athens County, Ohio, also being a part of Section 6, Township-4-North, Range-13-West, Lodi Township, Athens County, State of Ohio and more particularly described as follows;

Beginning at an existing iron pin being the northwest corner of a 4.317 acre tract transferred to Arthur R. and Sarah A. Tipton as recorded in Official Records Volume 172 at page 505 which bears North 00°13'30" West a distance of 557.18 feet and North 89°12'25" East a distance of 1975.55 feet from the assumed southwest corner of said Section 6, T-4, R-13;

Thence along the boundary of a 43.94 acre tract transferred to Anthony W. Pennington as recorded in Official Records Volume 146 at page 730 North 42°08'02" West a distance of 1263.12 feet to an existing iron pin;

Thence leaving the boundary of said 43.94 acre tract and along the boundary of a 55 acre tract transferred to Carl and Beulah May Pennington as recorded in Official Records Volume 92 at page 307 the following two courses;

- 1. North 83°31'59" East a distance of 1342.88 feet to an existing iron pin;
- 2. North 00°30'42" West a distance of 217.80 feet to a railroad spike set in the centerline of Township Road 100, Sand Ridge Road;

Thence along said centerline South 64°03'53" East a distance of 150.95 feet to a point being the northwest corner of a 1.04 acre tract transferred to Eddie R. Pennington as recorded in Official Records Volume 314 at page 657;

Thence leaving said centerline and along the west line of said 1.04 acre tract South 00°12'46" East passing thru and existing iron pin at a distance of 12.10 feet and going a total distance of 486.35 feet to an existing iron pin;

Thence leaving said 1.04 acre tract and along the boundary of a 2.00 acre tract transferred to William W. and Calla E. Allison as recorded in Official Records Volume 347at page 1153 the following two courses;

- 1. South 63°39'38" West a distance of 206.17 feet to an existing iron pin;
- 2. South 18°56'49" West a distance of 363.26 feet to an existing iron pin;

Thence leaving said 2.00 acre tract and along the boundary of a newly created 3.000 acre tract the following three courses;

- 1. South 83°22°03" West a distance of 129.38 feet to a 5/8" iron pin set;
- South 00°13'30" East a distance of 269.68 feet to a 5/8" iron pin set;
- 3. South 88°07'10" East passing thru a 5/8" iron pin set at a distance of 403.10 feet and going a total distance of 433.10 feet to a point in Township Road 100, Sand Ridge Road;

Thence leaving said 3.000 acre tract and along Township Road 100 South 00°13'30" East a distance of 40.03 feet to a point on the north line of said 4.317 acre tract;

Thence leaving said Township Road 100 and along said north line North 88°07'10" West passing thru an existing iron pin at a distance of 16.42 feet and going a total distance of 625.76 feet to the

principal point of beginning containing 21.023 acres more or less subject to all legal easements and rights of way.
