SITUATE IN AND BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 11, TOWN 4 NORTH, RANGE 13 WEST, LODI TOWNSHIP, ATHENS COUNTY, OHIO, BEING MORE PARTICULARLY BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT WHERE THE APPROXIMATE CENTERLINE OF MILL SCHOOL ROAD (ALSO KNOWN AS COUNTY ROAD NUMBER 42) INTERSECTS THE EAST LINE OF SECTION 11, SAID POINT BEING THE NORTHEAST CORNER OF THE 9.797 ACRE (TAXED) WENDY S. SHIELDS TRACT (OFFICIAL RECORD 526, PAGE 139)(SEE LAND CONTRACT TO DAVID W. AND BETH A. DILLON (OFFICIAL RECORD 560, PAGE 1764)), FROM WHERE A MARKED STONE FOUND DISTURBED AT THE NORTHEAST CORNER OF THE SOUTHEAST QUARTER OF SECTION 11 BEARS N 02°47'15" E 1589.61 FEET;

THENCE S 83°25'10" W 454.24 FEET, ALONG MILL SCHOOL ROAD AND WITH SAID 9.797 ACRE WENDY S. SHIELDS TRACT, TO A POINT IN THE CENTERLINE OF MILL SCHOOL ROAD AT A COMMON CORNER TO THE 29.173 ACRE (TAXED) CLIFFORD E. AND PAULA SUE MCGURK TRACT (OFFICIAL RECORD 408, PAGE 1099);
