Situated in the Township of Lodi, County of Athens, State of Ohio, and being a part of the Southeast Quarter of Section 24 and the Southwest Quarter of Section 18, Township 4N, Range 13W, of the Ohio Company's Purchase, and being more particularly described as follows;

Being a Survey of 3 Parcels conveyed to Ruth E. Hawk, Trustee, as recorded in O.R. Book 569, Page 2389, in the Athens County Deed Records, being all of Auditor's P.P.N. J010010060300) & P.P.N. J0100100604, and further described as follows;

Commencing at a stone found w/scribed 'X' marking the Northeast corner of the Northeast Quarter of Section 24, the same being the Northwest corner of the Northwest Quarter of Section 18;

Thence, S 03°20'48" W 2701.49 feet with the East line of Section 24, the same being the West line of Section 18, to an iron pin set marking the Southeast corner of a 53.13 Acre parcel conveyed to William C. & Mary Kathryn Cooley, as recorded in O.R. Book 12, Page 371, also being the Southwest corner of a 10.73Acre parcel conveyed to William C. & Mary Kathryn Cooley, as recorded in O.R. Book 12, Page 371, and being the **PRINCIPLE PLACE OF BEGINNING** of the **150.352 Acre parcel** herein to be described;

Thence, S 86°27'57" E 2580.83 feet with said "East-West" Half Section Line, the same being the South line of said parcel conveyed to Berry, ETAL (OR304,Pg.937), and extending along the South line of said 53.13 Acre parcel conveyed to Cooley (OR12,Pg.371), to the **PRINCIPLE PLACE OF BEGINNING**, passing over a railroad spike set in the centerline of Coolville Ridge Road (Co. Rod 75) at 883.31 feet, and containing **150.352 Acres**, more or less, and is subject to all legal easements, right of ways, zoning restrictions, and ordinances of record.

The above described 150.352 Acre parcel contains 50.899 Acres in Section 18 (P.P.N. J010010060400) and 99.453 Acres in Section 24 (P.P.N. J010010060400).

The bearings of the above description are based on the East line of Section 24, the same being the West line of Section 18, as being S 03°20'48" W, and is based on the O.D.O.T. CORS Network System South Zone.

All iron pins set are 5/8" o.d. reinforcing bars 30" long with red caps labeled "S.A. ENGLAND #7452".
