The Commissioners of Athens County, Ohio, proceeding this day to hear the petition of L.G.Worstell, Jr. and others, to obtain the annexation of the territory in their petition described to the City of Athens, and having in open meeting heard all the persons desiring to be heard for or against the granting of said petition and considered the affidavit presented with reference thereto, and being fully advised find that said petition contains all the matters required by law, that its statements are true, that the territory sought to be annexed is adjacent to the said City of Athens; that the petition contains a full description of said territory; that the map of said territory attached to the petition is accurate; that said petition is signed by all of the adult freeholders residing on the territory sought to be annexed; that the required legal notice of the petition has been given and that it is right and proper that said petition should be granted.

Mr. Bolin moved the adoption of the following Resolution:

"WHEREAS, the Board of Athens County Commissioners has considered the petition for annexation of certain territory to the City of Athens presented by L.G.Worstell, Jr. personally and as agent for others, in open hearing, and finds that all necessary steps have been taken therein according to law;

THEREFORE, BE IT RESOLVED: That the prayer of said petition be granted and that the territory described in said petition may be annexed to the City of Athens in accordance with law, and that a certified transcript signed by a majority of this Board of all the orders and proceedings of this Board relative to said petition and hearing thereon, together with said petition and map attached thereto, and all papers on file relating to said matter be deposited at once with the Auditor of said City. ORDINANCE NO. 1001

An Ordinance Accepting Application for Annexation
of Territory

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATHENS, OHIO:

SECTION I

That the application of L.G.Worstell, Jr., personally and as Agent for Rose Rutherford and C.B. Nye, for the annexation of the following described territory in the Township of Athens, in the County of Athens, and in the State of Ohio, and adjacent to the City of Athens, to-wit:

Commencing in the present corporation line of the City of Athens at a point which is found by running north 36 1/2 degrees east 40 feet and north 25 1/2 degrees east 209 feet from the northwest corner of Inlot No. 2911 in Northwood Addition to the City of Athens, said place of beginning being located in the center of Peach Ridge Road and the northwest corner of a tract of land owned by L.G.Worstell, Jr.; thence along the center of said Peach Ridge Road the following courses: north 28 1/2 degrees east 237.5 feet; north 27 1/2 degrees east 200 feet; north 18 degrees east 161 feet to the junction of said Peach Ridge Road and Stroud's Run Road; thence along the center of Stroud's Run Road north 40 degrees east 250 feet; thence north 52 degrees east 135.5 feet; thence leaving said Road south 54 1/2 degrees east 417.7 feet to a point located in the east line of Farm Lot No. 48 and being a cross on a native stone; thence north 4 1/2 degrees east along said Farm Lot line 865 feet to a stone located at the northeast corner of said Farm Lot No. 48; thence north 4 1/2 degrees east 136 feet along the west line of Farm Lot No. 47 to a point located 162 feet south of the northwest corner of said Farm Lot No. 47; thence south 58 1/2 degrees east 259 feet; thence north 80 degrees east 165 feet; thence south 70 1/2 degrees east 120 feet; thence south 4 1/2 degrees west 168 feet; thence south 81 1/2 degrees east 762 feet to the Stroud's Run Road; thence along Stroud's Run Road south 11 degrees west 391 feet; thence south 86 degrees east 548 feet to a point in the east line of Farm Lot No. 47; thence south 4 degrees west along said east line of Farm Lot No. 47, 1285 feet to a point located north 4 degrees east 254 feet from the southeast corner of said Farm Lot No. 47; thence north 85 1/2 degrees west 957 feet to the center of Cable Lane; thence along the center of Cable Lane north 53 3/4 degrees east 83 feet; thence north 14 degrees east 261 feet; thence leaving Cable Lane north 86 degrees west 886 feet to a point in the west line of Farm Lot No. 47 (located north 4 1/2 degrees east 548 feet from the southwest corner of said Farm Lot and the southeast corner of Farm Lot No. 48); thence north 4 1/2 degrees east

along said Farm Lot line 217.8 feet; thence south 83 1/2 degrees west 611 feet to the northeast corner of a tract now owned by L. G. Worstell, Jr., and the present corporation line of the City of Athens; said point being located north 83 1/2 degrees east 169 feet from the place of beginning; thence along said corporation line south 83 1/2 degrees west 169 feet to the place of beginning;

An accurate map of which territory, together with the petition for its annexation, and other papers relating thereto, and a certified transcript of the proceedings of the County Commissioners in relation thereto are on file with the Clerk of the Council of said City of Athens, be and the same is hereby accepted.

SECTION II

This Ordinance shall take effect and be in force from and after the earliest period allowed by law.

ORDINANCE NO. 1001

An Ordinance Accepting Application for Annexation
of Territory

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ATHENS, OHIO:

SECTION I

That the application of L.G.Worstell, Jr., personally and as Agent for Rose Rutherford and C.B. Nye, for the annexation of the following described territory in the Township of Athens, in the County of Athens and in the State of Ohio, and adjacent to the City of Athens, to-wit:

Commencing in the present corporation line of the City of Athens at a point which is found by running north 36 1/2 degrees east 40 feet and north 25 1/2 degrees east 209 feet from the northwest corner of Inlot No. 2911 in Northwood Addition to the City of Athens, said place of beginning being located in the center of Peach Ridge Road and the northwest corner of a tract of land owned by L. G. Worstell, Jr.; thence along the center of said Peach Ridge Road the following courses: north 28 1/2 degrees east 237.5 feet; north 27 1/2 degrees east 200 feet; north 18 degrees east 161 feet to the junction of said Peach Ridge Road and Stroud's Run Road; thence along the center of Stroud's Run Road north 40 degrees east 250 feet; thence north 52 degrees east 135.5 feet; thence leaving said Road south 54 1/2 degrees east 417.7 feet to a point located in the east line of Farm Lot No. 48 and being a cross on a native stone;
