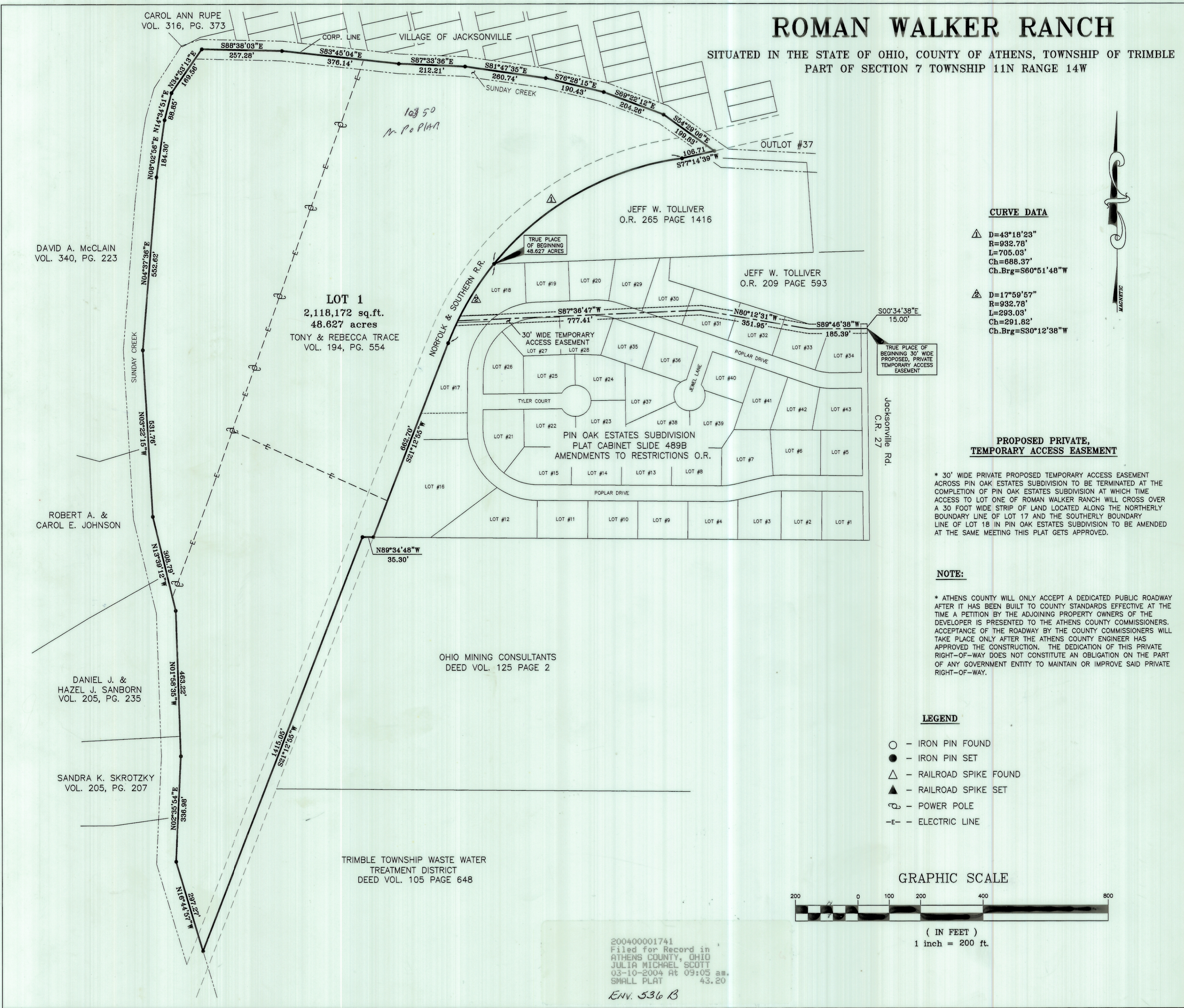

* 30' WIDE PRIVATE PROPOSED TEMPORARY ACCESS EASEMENT ACROSS PIN OAK ESTATES SUBDIVISION TO BE TERMINATED AT THE COMPLETION OF PIN OAK ESTATES SUBDIVISION AT WHICH TIME ACCESS TO LOT ONE OF ROMAN WALKER RANCH WILL CROSS OVER A 30 FOOT WIDE STRIP OF LAND LOCATED ALONG THE NORTHERLY BOUNDARY LINE OF LOT 18 IN PIN OAK ESTATES SUBDIVISION TO BE AMENDED AT THE SAME MEETING THIS PLAT GETS APPROVED.

NOTE:

* ATHENS COUNTY WILL ONLY ACCEPT A DEDICATED PUBLIC ROADWAY AFTER IT HAS BEEN BUILT TO COUNTY STANDARDS EFFECTIVE AT THE TIME A PETITION BY THE ADJOINING PROPERTY OWNERS OF THE DEVELOPER IS PRESENTED TO THE ATHENS COUNTY COMMISSIONERS. ACCEPTANCE OF THE ROADWAY BY THE COUNTY COMMISSIONERS WILL TAKE PLACE ONLY AFTER THE ATHENS COUNTY ENGINEER HAS APPROVED THE CONSTRUCTION. THE INDICATION OF THIS PRIVATE RIGHT-OF-WAY DOES NOT CONSTITUTE AN OBLIGATION ON THE PART OF ANY GOVERNMENT ENTITY TO MAINTAIN OR IMPROVE SAID PRIVATE RIGHT-OF-WAY.
