Situated in Fraction 13, Section 14, Town 6, Range 12, Rome Township, Athens County, Ohio and described as follows:

Commencing at the point where Athens County Road 53 intersects the north line of said Fraction 13; thence on an assumed bearing South 27°20'04° East 647.99 feet to a set iron pin, THE TRUE POINT OF BEGINNING; thence North 16°03'56° East 165.80 feet to a set iron pin; thence North 64°26'32" East 151.53 feet to a set iron pin; thence South 17°06'19" East (passing a set iron pin at 155.03 feet) for a total distance of 183.54 feet to a point in the center of Athens County Road 53; thence following along a random line slightly north of the center of said Athens County Road 53 South 64°33'54" West 29.04 feet to a point; thence South 42°58'17" West 174.13 feet to a point; thence leaving said Athens County Road 53 North 45°20'01" West (passing a set iron pin at 13.36 feet) for a total distance of 128.88 feet to the point of beginning containing 1.00 acre and being part of a 77.05 acre tract described in Volume 384 Page 831 of the Athens County Deed Records.

Note: All set iron pins are 5/8 inch diameter rebar 30 inches in length.


