DEED DESCRIPTION

Situated in the State of Ohio, County of Athens, Township of Rome, T-6, R-12, being a part of Thomas A. Sabo Et Al OR 285 Pg. 2006, being part of Fractions 18 & 36, and more particularly described as follows:

Beginning at an iron pin set at the Northeast Corner of Fraction 18; thence along the North Line of Fraction 18 South 88 Degrees 29 Minutes 40 Sconds West 973.01 feet to a stone found; thence South 00 Degrees 00 Minutes 00 Seconds West 1318.54 feet to an iron pin set and the place of beginning, passing an iron pin found at 785.21 feet; thence South 78 Degrees 12 Minutes 05 Seconds East 2135.61 feet to a railroad spike set in the centerline of St. Rt. 329, passing an iron pin set at 2085.61 feet; thence South 59 Degrees 44 Minutes 02 Seconds East 152.71 feet to a point in the Hocking River, passing an iron pin set at 30.00 feet; thence with said river South 36 Degrees 30 Minutes 40 Seconds West 343.66 feet to a point in the river; thence South 40 Degrees 40 Minutes 52 Seconds West 155.39 feet to a point in the river; thence leaving said river South 89 Degrees 23 Minutes 38 Seconds West 1916.74 feet to a stone found, passing a railroad spike set in the centerline of St. Rt. 329 at 133.38 feet and an iron pin set at 189.38 feet; thence North 00 Degrees 00 Minutes 00 Seconds West 927.97 feet to the place of beginning, containing 18.41 acres in Fraction 18 & 15.09 acres in Fraction 36, being 33.50 acres total, more or less, subject to all legal highways and easements.


