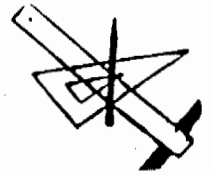

BEING A SURVEY OF PART OF THE NORTH HALF OF LOT #49, IN THE VILLAGE OF GUYSVILLE (FORMERLY SAVANNAH) AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

SITUATED THE STATE OF OHIO, COUNTY OF ATHENS, AND IN THE TOWNSHIP OF ROME, AND BEING IN THE NORTH HALF OF SECTION #26, TOWNSHIP 6, RANGE 12 AND BEING A PART OF THE NORTH HALF OF LOT #49, IN THE VILLAGE OF GUYSVILLE, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING, FOR REFERENCE, AT AN IRON PIN SET MARKING THE NORTHEAST CORNER OF LOT #49, SAID POINT BEING THE INTERSECTION OF THE WEST RIGHT-OF-WAY LINE OF UNION STREET (49.5 WIDE) AND THE SOUTH RIGHT-OF-WAY LINE OF GUY STREET (60' WIDE) "FORMERLY RAILROAD STREET", AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED:

THENCE, WITH THE WEST RIGHT-OF-WAY LINE OF UNION STREET, S 03°00'00" W 82.50 FEET TO AN IRON PIN SET IN THE NORTHERLY LINE OF A UNPLATTED STREET:

THENCE, WITH THE NORTHERLY LINE OF THE UNPLATTED STREET, N 87°34'05" W 48.63 FEET TO AN IRON PIN SET:

THENCE, WITH A NEW LINE THROUGH LOT #49, N 02°08'35" E 82.50 FEET TO AN IRON PIN SET IN THE SOUTH RIGHT-OF-WAY LINE OF GUY STREET:

THENCE, WITH THE SOUTH LINE OF GUY STREET, S 87°34'05" E 49.86 FEET TO THE PLACE OF BEGINNING. THE PARCEL AS SURVEYED CONTAINS 0.0932 ACRES OR 4,063 SQUARE FEET MORE OR LESS, SUBJECT TO ALL LEGAL EASEMENTS OF RECORD.

THE PARCEL DESCRIBED ABOVE IS SUBJECT TO AN INGRESS AND EGRESS EASEMENT OVER AND THROUGH AN EXISTING GRAVEL DRIVE HEREIN CONVEYED TO PARCEL #2, OR THE 0.0629 ACRE TRACT.

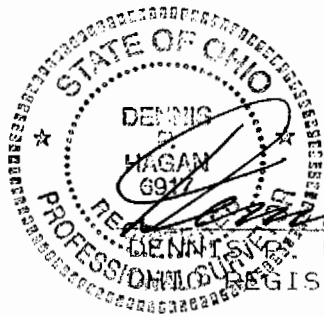

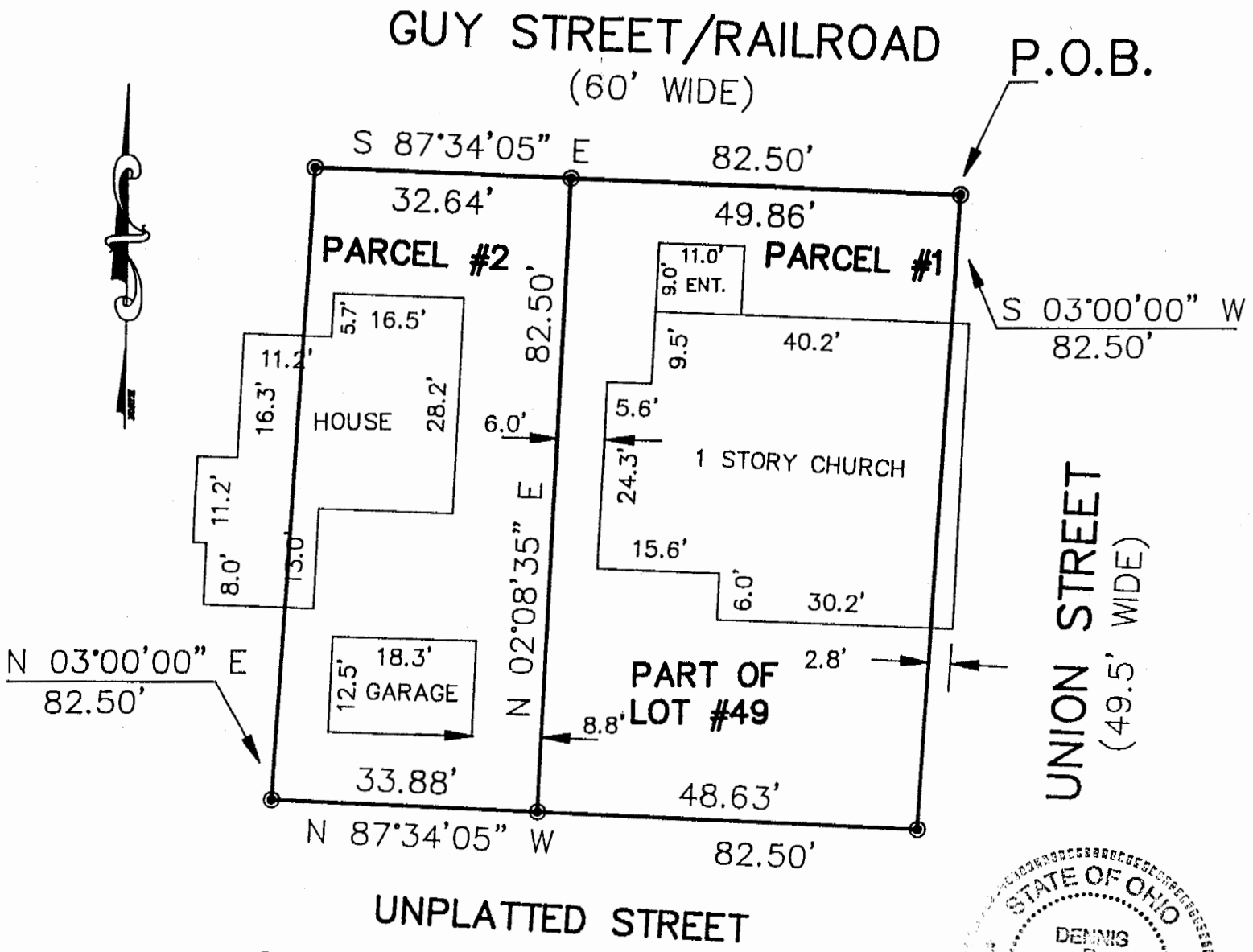

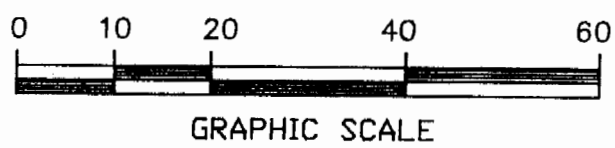
