## Description of 5.073 Acre Tract

thence leaving said State Route 329 and going North 06 degrees 25' 06" West, 92.51 feet to an iron pin set, having passed through an iron pin set at 40.53 feet; thence North 51 degrees 19' 34" West, 69.15 feet to an iron pin set; thence North 51 degrees 03' 58" West, 154.77 feet; thence North 23 degrees 26' 44" East, 186.77 feet to an iron pin set; thence North 19 degrees 41' 17" East, 100.90 feet to an iron pin set; thence North 78 degrees 03' 32" West, 470.71 feet to the place of beginning, containing 5.073 acres, more or less, of which, 3.249 acres, more or less, lies in Section 25 and 1.824 acres, more or less, lies in Section 26, but being subject to all legal right-of-ways, easements, and restrictions of record.

Also, a right-of-way, 20.00 feet in width, for ingress and egress purposes, the centerline of which is described as follows:
