Commencing at the northwest corner of Fraction 19, Section 20, Rome Township Athens County: thence on an assumed bearing and distance of South 17 degrees 06 minutes 58 seconds West 1910 feet to a point in the center of State Route 329 and THE TRUE POINT OF BEGINNING; thence along State Route 329 South 40 degrees 12 minutes 37 seconds West 74.01 feet to a point; thence South 48 degrees 34 minutes 26 seconds West 192.50 feet to a point; thence leaving said State Route 329 North 37 degrees 52 minutes 40 seconds West (passing a set iron pin at 26.00 feet) for a total distance of 121.48 feet to a set iron pin; thence North 39 degrees 42 minutes 48 seconds East (passing a set iron pin at 128.10 feet) for a total distance of 238.10 feet to a set iron pin; thence South 50 degrees 17 minutes 12 seconds East (passing a set iron pin at 128.33 feet) for a total distance of 148.93 feet to the point of beginning containing 0.7997 acres and being a part of a 106.97 acres (deed) tract described in Volume 216 Page 311 of the Athens County Deed Records. Leaving a remainder of 106.1703 acres.

Note: All set iron pins are capped, 5/8 inch diameter rebar, 30 inches in length.
