Commencing at the southeast corner of the southwest quarter of Section 30 Rome Township; thence on an assumed bearing North 02 degrees 11 minutes 00 seconds West 330.00 feet to a point; thence South 87 degrees 49 minutes 00 seconds West 1388.34 feet to a found iron pin at the northwest corner of a 1.524 acre tract described in Volume 359 Page 807 of the Athens County Deed Records: thence along the west line of said 1.524 acre tract South 16 degrees 15 minutes 00 seconds West 204.53 feet to a found iron pin; thence South 58 degrees 55 minutes 19 seconds East 200.08 feet to a point; thence South 18 degrees 03 minutes 13 seconds West 145.45 feet to a point; thence South 37 degrees 13 minutes 00 seconds West 95.36 feet to a point; thence South 07 degrees 39 minutes 50 seconds West 254.26 feet to a point; thence South 00 degrees 05 minutes 10 seconds West 158.63 feet to a set railroad spike in the center of Rome Township Road 229 THE TRUE POINT OF BEGINNING; thence continuing along said road and the west property line of a 9.00 acre tract described in Volume 313 Pages 245 and 915 of the Athens County Deed Records South 16 degrees 17 minutes 15 seconds East 55.27 feet to a set railroad spike; thence South 22 degrees 44 minutes 11 seconds East 124.00 feet to a set railroad spike; thence South 14 degrees 15 minutes 50 seconds East 212.37 feet to a set railroad spike; thence South 03 degrees 00 minutes 27 seconds East 87.54 feet to a set railroad spike; thence passing the southeast corner of aforementioned 9.00 acre tract and continuing along the Township Road 229 and the west property line of a 73.88 acre tract recorded in Volume 247 Page 383 of the Athens County Deed Records South 12 degrees 35 minutes 02 seconds West (passing a set railroad spike at 157.60 feet) for a total distance of 184.55 feet to a set railroad spike; thence leaving said road North 85 degrees 55 minutes 06 seconds West (passing a set iron pin at 15.14 feet) for a total distance of 203.30 feet to a set iron pin; thence North 85 degrees 47 minutes 31 seconds West (passing a set iron pin at 113.82 feet) for a total distance of 251.32 feet to a set iron pin; thence
