Beginning at an iron pin set at the Northeast Corner of Section 2; thence along the East Line of Section 2 South 01 Degrees 44 Minutes 19 Sconds West 7.47 feet to an iron pin set in the centerline of Twp. Rd. 532 and the place of beginning; thence continuing along said line South 01 Degrees 44 Minutes 19 Seconds West 135.12 feet to an iron pin set on the North R/W Line of the abandoned B & O Railroad; thence along said line North 56 Degrees 47 Minutes 43 Seconds West 371.42 feet to a railroad spike set, passing the South Line of Section 3 at 271.28 feet; thence along the centerline of Twp. Rd. 582 South 77 Degrees 45 Minutes 14 Seconds East 322.21 feet to the place of beginning, passing the North line of Section 2 at 282.17 feet, containing 0.49 acres total, being 0.36 acres in Section 2, being 0.13 acres in Section 3, more or less, subject to all legal highways and easements.


