Situated in the northwest quarter of Section 35, Town 6, Range 12, Rome Township, Athens County, Ohio and described as follows:

Commencing at an iron pin* at the northwest corner of said Section 35 at the northwest corner of a 65.01 acre tract described in Volume 299 Page 178 of the Athens County Deed Records; thence on an assumed bearing along the west line of said 65.01 acre tract South 2 degrees 34 minutes 34 seconds West, a distance of 1349.92 feet to a point at the southwest corner of said 65.01 acre tract, said point is witnessed by an iron pin* which bears North 87 degrees 24 minutes 45 seconds West a distance of 10.62 feet and is THE TRUE POINT OF BEGINNING; thence along the south line of said 65.01 acre tract South 87 degrees 24 minutes 45 seconds East, a distance of 1219.33 feet to an iron pin*; thence along the south line of said 65.01 acre tract and the west line of a 5.89 acre tract described in Volume 195 Page 273 of the Athens County Official Deed Records South 2 degrees 24 minutes 07 seconds West, passing an iron pin* at one of the southerly corners of said 65.01 acre tract and the northwest corner of said 5.89 acre tract at 180.20 feet, for a total distance of 495.43 feet to an iron pin* at the southwest corner of said 5.89 acre tract on the north line of a 26.24 acre tract described in Volume 195 Page 270 of the Athens County Official Deed Records; thence along the north line of said 26.24 acre tract North 87 degrees 27 minutes 19 seconds West, a distance of 1220.83 feet to an iron pin* at the northwest corner of said 26.24 acre tract; thence North 2 degrees 34 minutes 34 seconds East, a distance of 496.34 feet to the point of beginning and containing 13.889 acres, and being a part of a tract which originally contained 120.00 acres (before exceptons) as described in Volume 211 Page 355 of the Athens County Official Deed Records. *denotes calculated location of monument by previous surveys.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


