THENCE S 47°15'18" E A DISTANCE OF 4410.37' TO A SPIKE SET IN THE CENTERLINE OF BIG RUN ROAD (C-85) AND BEING THE TRUE POINT OF BEGINNING;

THENCE WITH SAID CENTERLINE OF BIG RUN ROAD FOR THE NEXT FOUR (4) CALLS S 72°01'42" E A DISTANCE OF 93.07' TO A SPIKE SET;

THENCE S 71°00'13" E A DISTANCE OF 50.78' TO A SPIKE SET;

THENCE S 67°10'37" E A DISTANCE OF 55.78' TO A SPIKE SET;

THENCE S 61°33'39" E A DISTANCE OF 81.24' TO A SPIKE SET IN THE INTERSECTION OF SAID BIG RUN ROAD AND BRUKER LANE (T-618) ALSO BEING A CORNER TO A 80.000 ACRES TRACT OWNED BY DANNY BAILEY ET. AL. IN O.R. 496 PG. 639;

THENCE WITH SAID BAILEY LINE S 21°00'41" W PASSING A 5/8" REBAR FOUND AT 26.71' AND A 5/8" REBAR FOUND AT 285.68' A TOTAL DISTANCE OF 390.53' TO A POINT IN BIG RUN CREEK ALSO BEING A CORNER TO A 19.125 ACRES TRACT OWNED BY JOSHUA L. WILLIAMS & JENNIFER L. BRADLEY IN O.R. 539 PG. 398;

THENCE WITH BIG RUN CREEK AND SAID BRADLEY LINE S 88°32'42" W A DISTANCE OF 223.02' TO A POINT IN FEDERAL CREEK ALSO BEING A CORNER TO A 10.388 ACRES TRACT OWNED BY TIMOTHY & ALLYSON WATKINS IN O.R. 568 PG. 1133;
