## **Description of 83.656 Acres**

The following described parcel is a retracement survey of the Donald J. Boyer property as conveyed by Official Records Volume 261, Page 703 of the Athens County Recorder's Office.

Situated in the State of Ohio, County of Athens, Township of Troy, part being in the northeast quarter of Section 36, Range 11 West, Township 5 North and part in the Township of Rome, being in the southeast quarter of Section 31, Range 11 West, Township 6 North of "The Ohio Company Purchase", and being bounded and described as follows:

**<u>BEGINNING</u>** at a marked stone found at the southeast corner of Section 31 and being the northeast corner of Section 36 (Note: Reference bearing on the east line of the southeast quarter of Section 31 used as a grid bearing of South 02°16'56" West.);

thence, from said Point of Beginning with the east line of the northeast quarter of Section 36, South 02°00'34" West a distance of 345.44 feet to a marked stone found in the north line of an 159.305 acres tract as conveyed to Scott P. Adams by Official Records Volume 405, Page 1891 of the Athens County Recorder's Office;

thence, with the north line of said Adams property, North 87°40'18" West a distance of 957.53 feet to a 5/8" iron pin set in the east line of the old abandoned railroad right-of-way now being owned by the Athens County Board of Commissioners as conveyed by Official Records Volume 548, Page 2053 of the Athens County Recorder's Office, passing through an iron pin set at a distance of plus 857.53 feet;

thence, with the east right-of-way line of said old railroad, the following 6 courses:

- 1. with a curve to the left, having a radius of 4,367.28 feet, an arc length of 29.73 feet, a central angle of 00°23'24", a chord bearing of North 48°45'50" West a chord distance of 29.73 feet to a 5/8" iron pin set;
- 2. thence North 88°40'49" West a distance of 15.67 feet to a 5/8" iron pin set;
- 3. thence, with a curve to the left, having a radius of 4,357.28 feet, an arc length of 74.74 feet, a central angle of 00°58'58", a chord bearing of North 49°36'32" West a chord distance of 74.74 feet to a 5/8" iron pin set;
- 4. thence North 50°06'01" West a distance of 1,210.92 feet to a 5/8" iron pin set, passing through a 5/8" iron pin set in the north line of Section 36 and being the south line of Section 31 at a distance of plus 460.77 feet;
- 5. thence South 39°53'59" West a distance of 10.00 feet to a 5/8" iron pin set;
- 6. thence North 50°06'01" West a distance of 929.39 feet to point in the center of an arch culvert of a run passing under said old railroad;

- 2. thence North 00°33'21" East a distance of 166.98 feet to a 5/8" iron pin set;

- 3. thence North 30°48'21" East a distance of 455.40 feet to a 5/8" iron pin set;
- 4. thence North 46°41'39" West a distance of 92.40 feet to a 5/8" iron pin set;
- 5. thence North 39°20'34" West a distance of 111.85 feet to a point on the east edge of Township Road No. 574 (Frost Hill Road), passing through a 5/8" iron pin set at a distance of plus 81.85 feet;

thence, along the east edge of Township Road No. 574, North 30°19'26" East a distance of 648.78 feet to a 5/8" iron pin set on the east side of said road;

thence North 87°43'51" West a distance of 20.95 feet to a railroad spike set in the travelled portion of Township Road No. 574;

thence, in the travelled portion of said road, North 13°05'09" West a distance of 51.85 feet to a railroad spike set in the common boundary with a 112.91 acres tract as conveyed to Bruce A. Johnson by Official Records Volume 206, Page 171 of the Athens County Recorder's Office;

- 4. thence South 39°58'04" West a distance of 258.94 feet to a 34" iron pin found uncapped;
- 5. thence South 55°14'48" East a distance of 342.49 feet to a ¾" iron pin found uncapped;
- 6. thence South 07°11'04" West a distance of 216.23 feet to a 34" iron pin found uncapped;
