

LEGAL DESCRIPTION 11.550 Acres

Situated in the State of Ohio, County of Athens, Township of Rome, being within Section 32, Township 6, Range 11, Ohio Company's Purchase, being part of that 148.46 acres as described in deed to Victoria E. Haley of record in Official Record 548, Page 2279, all being of record in the Recorder's Office, Athens County, Ohio and being further bounded and described as follows:

Commencing at the southeast corner of said Section 32 and northeast corner of Section 31, Township 6, Range 11;

Thence North 88°32′29″ West, a distance of 4216.87 feet, with the south line of Section 32 and north line of said Section 31, in part along a south line of that 36.220 acre tract described in deed to Boyd C. Sidwell, Jr. and Debra L. Sidwell, of record in Official Record 540, Page 2267, to a sandstone monument found (1 foot deep) at common corner of 148.46 acres and said 36.220 acres, also being at the **Point of True Beginning** of the herein described tract of land;

Thence North 88°32′29″ West, a distance of 276.63 feet, passing an iron pin set at distance of 226.63 feet, with the south line of said Section 32 and said 148.46 acres and a north line of said Section 31 and said 36.220 acres, to a point on the east bank of the Hocking River;

Sidwell, Jr. and Debra L. Sidwell, of record in Official Record 540, Page 2267 and that 58.602 acre tract described in deed to David B. Humphrey and Rebecca L. Humphrey, of record in Deed Book 342, Page 436;
