

In Re The Annexation of Territory To The Village of Trimble, State of Ohio

Transcript of Proceedings Before Commissioners.
Petition

To The Commissioners of Athens County, State of Ohio:
The Village of Trimble of the County of Athens and State of Ohio, respectfully represents that by an ordinance duly passed by its council on the 15th day of March, 1917, the following described territory, to-wit:-

Commencing at the present corporation line of said village on the east line of Section No. 8 in Trimble Township, Athens County, Ohio; thence north along the east line of said Section No. 8 to the public road known as the John & Fever Road; thence along the south side of said road to the west side of the road leading from Trimble to Gloucester; thence north along the west side of said road leading from Trimble to Gloucester to the north line of Section No. 8; thence west along the north line of said Section No. 8 to the west line of fraction No. 3; thence north along said west line to the Gloucester corporation line; thence following the Gloucester Corporation line to the middle of Sunday Creek; thence following the middle of Sunday Creek to the present corporation line of said Village of Trimble; thence easterly along the north line of the present corporation line to the place of beginning. was authorized to be annexed to said Village. An accurate map of which territory is hereto attached. And said Village respectfully petitions that said territory may be annexed to said Village.

In The Matter of The Application of the Village of Trimble, State of Ohio, For The Annexation of Territory to said Village.

Entry.

The Commissioners of the County of Athens, State of Ohio, proceeding this day to hear the petition of the Village of Trimble, State of Ohio, to obtain the annexation of the territory in its petition described to the Village of Trimble, Ohio, and having in open meeting heard all the persons desiring to be heard for or against the granting of said petition, and being fully advised find that said petition contains all the matters required by law, and that its statements are true, that the territory sought to be annexed is adjacent to said Village; that the petition contains a full description of the territory; that the map of said territory attached to the petition is accurate; that the required legal notice of the petition has been given; and that it is right and proper that said petition should be granted.

It is hereby ordered that the prayer of said petition be granted, and that the territory described in said petition may be annexed to said Village in accordance with law, and that a certified transcript signed by a majority of this Board of all the orders and proceedings of this board relative to said petition and hearing thereon, together with said petition and map attached thereto, and all the papers on file relating to said matter be deposited at once with the Clerk of said Village of Trimble, Ohio.

Ordinance No. _____

An Ordinance To Authorize The Annexation of Certain Territory To The Village of Trimble, State of Ohio,

Be it ordained by the Council of the Village of Trimble, State of Ohio:

Section 1. That the annexation of the following described territory, to-wit:-

Commencing at the present corporation line of said village on the east line of Section No. 8 in Trimble Township, Athens County, Ohio; thence north along the east line of said section No. 8 to the public road known as the John & Fever Road; thence along the south side of said road to the west side of the road leading from Trimble to Gloucester; thence north along the west side of said road leading from Trimble to Gloucester to the north line of section No. 8; thence west along the north line of said Section No. 8 to the west line of fraction No 3; thence north along said west line to the Gloucester corporation line; thence following the Gloucester corporation line to the middle of Sunday Creek; thence following the middle of Sunday Creek to the present corporation line of said Village of Trimble; thence easterly along the north line of the present corporation line to the place of beginning. be and the same is hereby authorized

Section 2. That the Village Solicitor, S. M. Johnson, be and he is hereby authorized to prosecute the proceedings necessary to effect such annexation.

Section 3. This ordinance shall take effect and be in full force from and after the earliest period allowed by law.
