Beginning at a damaged 5/8" iron pin with 1-1/4" plastic ID cap stamped SEY & ASSOC. Found at the North corner of said Lot 5; thence South 48 degrees 58 minutes 01 second East a distance of 137.52 feet to a 5/8" iron pin set at the East corner of said Lot 5:

thence South 3 degrees 41 minutes 10 seconds West a distance of 93.29 feet to a 5/8" iron pin set at the South corner of said Lot 5, from which a 5/8" iron pin found bears South 3 degrees 41 minutes 10 seconds West at a distance of 125.62 feet;

thence North 48 degrees 58 minutes 01 second West a distance of 196.03 feet to a 5/8" iron pin set at the West corner of said Lot 5 and passing a 5/8" iron pin found at a distance of 5.28 feet;

thence North 42 degrees 31 minutes 00 seconds East a distance of 74.19 feet to the point of beginning, containing .284 acres more or less, and subject to any public or private easements of record.

The above .284 acre survey is intended to describe all of Lot 5 of the Samuel Peach's Subdivision as deeded to Jeffery A. and Misty M. Lehman, deed reference Volume OR240, Page 82, Athens County Recorder's Office. 
