Legal Description 5.010 Acres

Situated in the Township of Trimble, County of Athens, State of Ohio, and being a part the Southeast Quarter of Section 19, Township 11N, Range 14W, and being more particularly described as follows;

Being a Survey of a part of a 32.767 Acre parcel conveyed to Applachian Investments, LLC, as recorded in O.R. Book 472, Page 598, and all of a 0.500 Acre parcel conveyed to Applachian Investments, LLC, as recorded in O.R. Book _____, Page _____, in the Athens County Deed Records, and being all of Auditor's Parcel No. M01-0010066302 and part of Auditor's Parcel No. M01-0010074100.

Commencing at a non-accessible point in a creek marking the Southeast corner of Section 19, and being on the line between Trimble and Dover Townships;

Thence, N 88°24'55" W 1.47 feet with the line between said Trimble and Dover Townships, to an inaccessible point in a creek, being the Northeast corner of Tract 2 conveyed to Mary H. Hughes, as recorded in O.R. Volume 162, Page 846, being the Southeast corner of said 0.500 Acre parcel of which this description is a part, and being the **PRINCIPLE PLACE OF BEGINNING** of the **5.010 Acre** parcel herein to be described;

Thence. N 88°24'55" W 118.76 feet continuing with said Township Line, the same being the North line of said parcel conveyed to Hughes (O.R.162, Pg.846), also being the South line of said 0.500 Acre parcel (O.R. Volume ____, Page ____) to an iron pin set marking the Southwest corner thereof, also being the Southeast corner of Tract 1 conveyed to Hughes (O.R.162, Pg.846);

Thence following an existing fence line along the East line of Tract 1 conveyed to Hughes (O.R.162, Page 846), the same being the West line of said 0.500 Acre parcel (O.R.____, Page _____) of which this description is a part, with a curve to the right (radius = 1735.62 feet, delta angle 11°14'17", arc length 340.43 feet) with a chord bearing N 50°44'36" W 339.88 feet to an iron pin set on the North line thereof, and being on the South line of said 32.767 Acre parcel conveyed to Applachian Investments, LLC, as recorded in O.R. Volume 472, Page 598;

Thence, S 79°53'26" W 162.64 feet with the South line of said parcel conveyed to Applachian Investments, LLC. (O.R.472, Pg.598), the same being the North line of said Tract 1 conveyed to Hughes (O.R.162, Page 846), to an iron pin set;

Thence with a line across said parcel conveyed to Applachian Investments LLC (O.R.472, Page 598) of which this description is a part, with the following three (3) courses and distances:

- N 36°57'53" W 493.49 feet to an angle point in the centerline of Green's Run Creek: said angle Point bears S 35°36'14" W 4.32 feet from an iron pin set;
- 2) N 62°25'06" W 194.28 feet to an angle point in the centerline of Green's Run Creek;
- 3) N 33°17'13" E 246.85 feet to the North line thereof in the centerline of State Route 685, passing over an axle found at 24.80 feet, and passing over an iron pin set at 210.65 feet;

Thence with the North line of said parcel conveyed to Applachian Investments LLC (O.R.472, Page 598) of which this description is a part, the same being the centerline of State Route 685, with the following two (2) courses and distances:

4) S 69°15'20" E 165.71 feet to a mag nail set at an angle point;

5) S 41'17'23" E 313.01 feet to the Northwest corner of a 0.284 Acre parcel conveyed to Greens Run Christian Church, as recorded in O.R. Book 291, Page 2431;

Thence with the boundary of said 0.284 Acre parcel conveyed to Greens Run Christian Church (O.R.291, Pg.2431), with the following three (3) courses and distances:

- 6) S 38°20'00" W 119.77 feet to a 5/8" o.d. iron pin found, and passing over a 5/8" o.d. iron pin found at 11.77 feet;
- 7) S 58°28'16" E 183.21 feet to a 5/8" o.d. iron pin found;
- 8) N 17°46'33" E 74.40 feet to a 5/8" o.d. iron pin found in the Right of Way of State Route 685;

Thence, S 41°17'57" E 292.50 feet to an iron pin set at the edge of pavement of State Route 685: said iron pin set bears N 41°17'57" W 330.00 feet from the Southeast corner of Section 19;

Thence, S 79°53'26" W 94.26 feet to an iron pin set marking the Northeast corner of said 0.500 Acre parcel (O.R. _____, Page _____) of which this description is a part;

Thence with the East line of said 0.500 Acre parcel conveyed to Applachian Investments, LLC, (O.R. _____, Pg. _____), of which this description is a part, with a curve to the left (radius 1675.62 feet, delta angle 13°13'54", arc length 386.96 feet) with a chord bearing S 53°11'26" E 386.10 feet to the PRINCIPLE PLACE OF BEGINNING, and containing 5.010 Acres, more or less, and is subject to all legal easements, restrictions, and zoning ordinances of record.

The above described 5.010 Acre parcel contains all of a 0.500 Acre parcel conveyed to Applachian Investments, LLC, as recorded in O.R. Book _____, Page _____, and 4.510 Acres from a 32.767 Acre parcel conveyed to Applachian Investments, LLC, as recorded in O.R. Book 472, Page 598, and being part of Auditor's Parcel No. M01-0010064101.

Subject to the Flood Zone A Plain, as per Community Panel No. 390009C0038C, dated May 7, 2009.

Bearings of the above description are based on the line between Trimble and Dover Townships as being N 88°24'55" W, and is an assumed Meridian used to denote angles only.

All iron pins set are 5/8" o.d. iron pins 30" long with red caps labeled "S.A. ENGLAND #S-7452".
