Commencing at a found iron pin at the northeast corner of a 21.17 acre tract described in Volume 351 Page 475 of the Athens County Deed Records; thence along the west line of Section 20 North 03 degrees 45 minutes 00 seconds East 828.22 feet to a found iron pin the southwest corner of Fraction 25; thence continuing along said section line North 03 degrees 45 minutes 00 seconds East 984.48 feet to the TRUE POINT OF BEGINNING; thence continuing along the west line of Section 20 and the east property line of a 537.54 acre tract described in Volume 127 Page 638 of the Athens County Deed Records North 03 degrees 45 minutes 00 seconds East 198.00 feet to a set iron pin on the south side of Athens County Road 67; thence along the south property line of a 1.08 acre tract described in Volume 332 Page 125 of the Athens County Deed Records North 89 degrees 16 minutes 44 seconds East 332.00 feet to a set iron pin in said road, the southwest corner of a 0.39 acre tract described in Volume 370 Page 857 of the Athens County Deed Records and known as the Airshaft Lot; thence along the south property line of said Airshaft Lot South 54 degrees 12 minutes 00 seconds East (passing a set iron pin at 13.66 feet) for a total distance of 133.90 feet to a set iron pin the southeast corner of said Airshaft Lot; thence along the west property line of a tract described in Volume 300 Page 193 of the Athens County Deed Records South 23 degrees 22 minutes 00 seconds West (12 rods) 198.00 feet to a set iron pin the southeast corner of a 2 acre tract described in Volume 334 Page 63 of the Athens County Deed Records; thence along the common property line of said 2 acre tract and a 20 acre tract described in Volume 293 Page 206 of the Athens County Deed Records North 81 degrees 09 minutes 29 seconds West (23 rods) 379.50 feet to a set iron pin the point of beginning containing 2.1488 acres and being a more accurate description of the same premises conveyed in Volume 334 Page 63 of the Athens County Deed
