Situated in the Southeast quarter of Section 25, Town 11, Range 14, Trimble Township, Athens County,
Ohio and described as follows:

Commencing at the Northwest corner of the Southeast quarter of Section 25; thence on an assumed bearing of South 25 degrees 39 minutes 43 seconds East, a distance of 1374.01 feet to an iron pin set, THE TRUE POINT OF BEGINNING; thence South 11 degrees 53 minutes 27 seconds East (passing a set iron pin at 295.64 feet) a distance of 313.50 feet to a point in the center of State Route 685; thence along the center of said State Route 685 the following five bearings and distances 1. South 85 degrees 43 minutes 53 seconds West, a distance of 13.69 feet to a point; thence 2. South 86 degrees 53 minutes 33 seconds West, a distance of 125.02 feet to a point; thence 3. South 84 degrees 22 minutes 06 seconds West, a distance of 116.05 feet to a point; thence 4. South 75 degrees 18 minutes 48 seconds West, a distance of 100.05 feet to a point; thence 5. South 68 degrees 52 minutes 58 seconds West, a distance of 8.50 feet to a point; thence leaving the said State Route 685 North 25 degrees 25 minutes 45 seconds West (passing a set iron pin at 17.05 feet) for a total distance of 258.26 feet to a set iron pin; thence North 31 degrees 14 minutes 10 seconds East, a distance of 203.53 feet to a set iron pin; thence South 79 degrees 59 minutes 12 seconds East, a distance of 304.07 feet to the point of beginning and containing 3.1307 acres, and being a part of a 81.71 acre tract described in Volume 125 Page 505 of the Athens County Official Deed Records.

Note: Unless otherwise noted, all set iron pins are 5/8 inch diameter rebar and 30 inches in length and capped with a plastic identification marker inscribed L.F. Swoyer R.L.S. 6765.


