Situated in Section 7, Town 11, Range 14, Trimble Township, Athens County, Ohio, and being a part of a 11.098 acre tract now belonging to Tony and Rebecca Trace described as Parcel Id # M01 001 00002-03 and Instrument # 1995-00001572 and located in Volume 194 Page 554 Official Records of Athens County and being more particularly described as follows:

Commencing and beginning at an iron pin found at the Northeast corner of Lot 21 in Pin Oak Subdivision;

thence, following the North line of said Subdivision, North 71 degrees 20 minutes 06 seconds West, a distance of 82.18 feet to an iron pin found;

thence North 87 degrees 44 minutes 49 seconds West, a distance of 82.52 feet to an iron pin set; thence South 87 degrees 57 minutes 57 seconds West, a distance of 164.59 feet to an iron pin found; thence North 41 degrees 07 minutes 12 seconds West, a distance of 103.96 feet to an iron pin set at the point of curvature of a non-tangent curve, concave to the southeast, having a radius of 175.00 feet, a central angle of 48 degrees 25 minutes 05 seconds, and a chord of 143.52 feet bearing South 24 degrees 35 minutes 40 seconds West;

thence southwest along said curve, a distance of 147.88 feet to an iron pin set at the Northeast corner of Poplar Drive;

thence, along said Drive, North 89 degrees 36 minutes 52 seconds West, a distance of 50.00 feet to an iron pin found at the Northwest comer of Poplar Drive said iron pin found being the point of curvature of a non-tangent curve, concave to the southeast, having a radius of 225.00 feet, a central angle of 44 degrees 29 minutes 46 seconds, and a chord of 170.38 feet bearing North 22 degrees 38 minutes 01 second East;

thence northeast along said curve, a distance of 174.73 feet to an iron pin set;

thence South 87 degrees 59 minutes 33 seconds West, a distance of 101.80 feet to a point in the East Line of Norfolk and Southern Rail Road, said point being the point of curvature of a non-tangent curve, concave to the southeast, having a radius of 932.78 feet, a central angle of 13 degrees 50 minutes 03 seconds, and a chord of 224.67 feet bearing North 31 degrees 24 minutes 29 seconds East;

thence, leaving said Subdivision following the East line of said Rail Road, northeast along said curve, a distance of 225.22 feet to an iron pin found, passing iron pins found at 5.67 feet and at 28.42 feet; thence, leaving said Rail Road, North 88 degrees 02 minutes 24 seconds East, a distance of 564.40 feet to an iron pin set;

thence South 1 degree 14 minutes 56 seconds West, a distance of 73.25 feet to an iron pin found; thence South 72 degrees 49 minutes 42 seconds East, a distance of 84.81 feet to an iron pin set; thence, on a random line, South 9 degrees 45 minutes 50 seconds West, a distance of 515.17 feet to an iron pin set in the North line of the aforementioned Pin Oak Subdivision, passing iron pins set at 144.95 feet and at 384.62 feet;

thence, following said Subdivision, North 89 degrees 35 minutes 04 seconds West, a distance of 131.10 feet to an iron pin found;

thence North 0 degrees 38 minutes 58 seconds West, a distance of 268.44 feet to the POINT OF BEGINNING, passing iron pins found at 73.00 feet and at 150.73 feet; said described tract containing 5.653 acres (246,233.7508 square feet).

Commencing and beginning at an iron pin set at the Northwest corner of Lot 21 in Pin Oak Subdivision, said iron pin set being the beginning of a curve, concave to the southeast, having a radius of 175.00 feet, a central angle of 48 degrees 25 minutes 05 seconds, and a chord of 143.52 feet bearing South 24 degrees 35 minutes 40 seconds West;

thence North 89 degrees 36 minutes 52 seconds West, a distance of 50.00 feet to an iron pin found, said iron pin found being the point of curvature of a non-tangent curve, concave to the southeast, having a radius of 225.00 feet, a central angle of 44 degrees 29 minutes 46 seconds, and a chord of 170.38 feet bearing North 22 degrees 38 minutes 01 second East;

thence northeast along said curve, a distance of 174.73 feet to an iron pin set;
