0.115 Acres


Description of a tract of land situate Ohio Company Purchase, Town 11, Range 14, Section 15, Trimble Township, Village of Glouster, Ohio.
Being all of the lands deeded to the Estate of David L. McCoy, and being referenced in Official Record Book 520, pages 2369-2370.

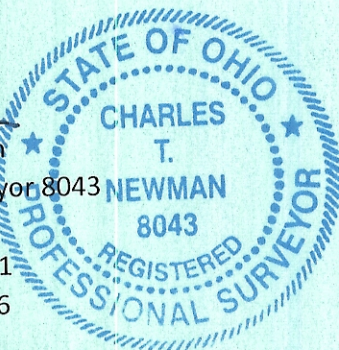
Beginning at an iron pin found at the northwest corner of Lot Number 343 of the O.D. Jackson Addition to the Village of Sedalia;


Thence S67°03'45"E 100.00 feet along the south right-of-way of Morgan Street to an iron pin set at the point of beginning of the tract herein described;

- 3.) Thence N67°08'27"W 105.39 feet along a common boundary to (McCoy 520-2369), (Morris 300-128) and (McClelland 406-1859) to an iron pin set;
- 4.) Thence N21°59'12"E 50.00 feet along a common boundary to (McCoy 520-2369) and (McClelland 406-1859) to the point of beginning containing a total of 0.115 acres.

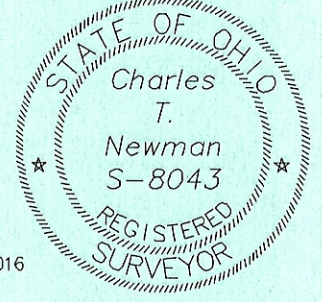

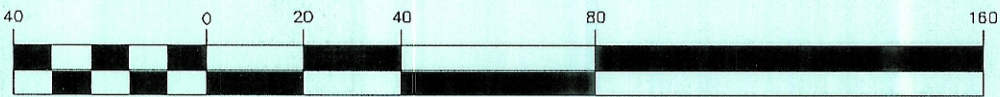
